In compliance to applicable regulation(s) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI-LODR), it is to inform that the 46th Annual General Meeting (AGM) of NHPC Limited will be held on Thursday, the 25th day of August, 2022 at 12:30 P.M. (IST) through Video Conference (VC)/ Other Audio Visual Means (OAVM), in accordance with applicable provisions of the Companies Act, 2013 (the Act) and relevant circulars issued by Ministry of Corporate Affairs (MCA) & Securities and Exchange Board of India (SEBI). The Notice of 46th AGM and Annual Report 2021-22 shall be submitted in due course and will also be made available on the Company's website www.nhpcindia.com, websites of Stock Exchanges i.e BSE Limited and National Stock Exchange of India Limited at www.nseindia.com respectively, and on the website of e-voting service provider i.e. M/s National Securities Depository Limited (NSDL) at www.evoting.nsdl.com.

In compliance to Regulation 42 of the SEBI-LODR, it is to inform that:

- a) The Company has fixed Thursday, August 11, 2022 as "Record Date" for determining entitlement of members to receive final dividend [as recommended by the Board of Directors @ 5.00% (Rs.0.50 per equity share) on the paid-up equity share capital of the Company] for the financial year 2021-22, if declared at the AGM. The members, whose name appear in the Register of Members/ List of Beneficial Owners as on the record date will be entitled to receive final dividend. The final dividend, if declared at the AGM, will be paid as per the provisions of the Act.
- b) The Register of Members and Share Transfer Books of the Company will remain closed from Friday, August 12, 2022 to Thursday, August 25, 2022 (both days inclusive) for the purpose of 46th AGM of the Company.
