In continuation to our earlier letter dated 21.01.2021 and in compliance to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is to inform that the Board of Directors of NHPC Limited in its meeting held today i.e. Sunday, March 21, 2021 *inter-alia* has approved the proposal regarding formation of a Joint Venture (JV) Company for implementation of Ratle Hydroelectric Project (850 MW) in the Chenab River Basin in UT of Jammu and Kashmir.

The Board has also accorded its investment approval to contribute initial equity of Rs.51 Crore by NHPC Limited in the JV Company, to be promoted jointly by NHPC (51%) and JKSPDCL (49%).
