INTRODUCTION

As on date NHPC Limited has become the largest organisation for hydropower development in India, with capabilities to undertake all the activities from conceptualization to commissioning in relation to setting up of hydro projects. NHPC Limited has also diversified in the field of Solar & Wind power.

NHPC Limited presently has an installation base of 7071.2 MW from 24 power stations including two no. projects in JV mode. NHPC including its JVs/ Subsidiaries, is presently engaged in the construction of 11 projects aggregating to a total installed capacity of 7539 MW. In addition, 8 projects aggregating to a total installed capacity of 7652 MW are Under Clearance Stage which includes five projects by NHPC on its own and three projects in JV mode. Further, 5 projects aggregating to a total installed capacity of 2455 MW are in Survey & Investigation Stage which includes three Hydroelectric projects (1130 MW) and two Pumped Storage Projects (1325 MW) being undertaken by NHPC.








2. DULHASTI POWER STATION:

I) Initiatives during COVID-19 & Health Camps

Going beyond the business boundaries, the pro-active approach works towards the sustainability of the society in the face of up-gradation in life style. CSR has become an effective tool to work in the line of sustainable development Goals (SDG's) with a strong focus on social performance indicated in the CSR Projects of the Organisation. The SDG's otherwise known as Global Goals, are a universal call to action to end poverty, protect the planet and ensure that all people enjoy peace and prosperity.

At present CSR is thriving and even customers are interested in companies contribution in society at large. Indian companies are working side by side with Govt. to tackle some serious challenges faced by communities in the country. The aim is to help people live better and enable the less privileged section of the society. Dulhasti Power Station, NHPC supports a comprehensive CSR programme covering a gamut of initiatives including education and health support programmes for the communities around the Corporation's establishments all across the country.

Dulhasti Power Station of NHPC is one of the highest performing Power Station with its significant presence in Jammu & Kashmir and neighbouring states with the latest skill set. Dulhasti Power Station supports a comprehensive CSR programme covering a gamut of initiatives including health support programme for the communities around the establishment. Dulhasti Power Station is working with an inspiring model of community well-being and national identity.

Dulhasti Power Station has been acting as an agency providing a robust platform to the civil society organisations joining hands for strengthening responsible business practices.

Doctors and medical staff across Dulhasti Power Station sensitized employees and local residents about COVID-19. Posters / pamphlets sourced from Ministry of Health, WHO etc were displayed and webcast on COVID-19 was also organized. Dulhasti Power Station has prepared its plan work with local communities and government to provide suitable sanitizing facilities. Hand sanitizers, masks, gloves and other PPEs have been provided. Office buildings, Markets, installations across power stations, hospitals, community halls and other public areas are being sanitized regularly.



In addition, villages, areas in the vicinity of Power Station have also been sanitized and medical camps were organized with the consent of district administration. In this effort about ten thousand litres of disinfectant and medicines have been distributed. There has been a constant effort to spread awareness regarding inculcating a habit of hygiene and sanitation. The No. of beneficiaries in Medical camps are 327 and the total no. of beneficiaries in Power station Hospital are 4542.

II) Donating Ambulance to Sewa Bharti, Jammu:

The entire health infrastructure in the country is under tremendous pressure & facing huge scarcity of medical infrastructure in wake of sudden spike in COVID patients during the 2nd wave. Therefore, during this pandemic time, it becomes imperative upon NHPC to strengthen the medical infrastructure of the agencies under its CSR initiatives to the extent possible for the wellbeing of the society.

Dulhasti Power Station, NHPC has donated a fully-equipped ambulance to Sewa Bharti (A NGO prominently engaged in the service of Community) at a cost of Rs. 25 Lakh as part of its CSR activities. The ambulance is equipped with advanced life support system and other equipment including a multi-channel monitor, defibrillator, ventilator, oxygen cylinder, humidifier amongst others to support the transportation of patients from far flung areas of Kishtwar, Doda and Udhampur districts in case of an emergency.



A flag off event of the vehicle took place in the presence of Shri Jitendra Singh, Hon. Minister of State, PMO, Govt. of India & M.P.(Lok Sabha) from Udhampur (J& K) and Shri Abhay Kumar Singh, CMD, NHPC on 28.08.2021.

III) "Arogya" Health Care Programme in Doda District

Doda district is full of hilly areas and it is very difficult to transport the critical patients to Jammu. Out of the total Doda population for 2011 census, 7.97 percent lives in urban regions of district. In total 32, 689 people live in urban areas of which males are 18, 211 and females are 14,478.





NHPC CSR activities are focused on three main areas – education, environment and healthcare. Furthering its commitment to improve the well being of the communities in which it operates, NHPC announced the mobile health care programme for Common man in Doda District through its "Arogya" initiative.

Arogya, a project powered by NHPC Ltd., has been providing quick diagnostic tests with quality results free of cost. Using Arogya, over 1962 diagnostic tests have been conducted with over 3,712 beneficiaries (Male patients-1710 & Female patients-2002).

IV) "Education" initiative through Kendriya Vidyalaya, Kishtwar

As part of NHPC's Corporate Social Responsibility exercise, Dulhasti Power Station is running school i.e. Kendriya Vidyalaya, Kishtwar within the campus area of Power Station. The school was set up principally for providing education to the children of its staff members. At present, this School confer exclusive expectations of instruction.

Over 938 students attend the School. Instructors at the school are qualified and experienced. Their training strategies are always assessed and changed when necessary.

Supporting the school education today will nurture citizens of tomorrow. It is felt that building a good base for holistic learning will contribute to a developed society. NHPC contributed on education for outsider students through Kendriya Vidyalaya, Kishtwar for the benefit of 862 no of students out of which 482 no. of male and 380 no. of female students. It includes 113 no. of SC, 35 no. of ST, 34 no. of OBC & 680 no of General category students.

V) Swachchh Vidyalaya Abhiyaan

Keeping its commitment towards "Swachchh Vidyalaya Abhiyaan", Dulhasti Power Station launched an ambitious programme to improve and repair 68 toilets in 34 Schools in Kishtwar Districts and facilitated with water supply and water tanks. The initiative aims to support, complement and significantly contribute to Government of India's initiative "Swachchh Vidyalaya Abhiyaan" aiming to make India Open Defecation free which is being implemented across the country as a national people's movement. The key component of the programme is to drive behaviour change communication towards hygiene and sanitation.

पश्चात सीएसआर&एसडी स्कीम के तहत यह फंड स्वीकृत हुआ तथा इस फंड को MoU के अनुसार release करने की ज़िम्मेदारी एनएचपीसी उरी-। को दी गयी है।



6. Chutak Power Station

Chutak Power Station is situated at a very challenging terrain in the Union Territory of Ladakh. Chutak Power Station remains cut-off from road connectivity during winter season i.e. November to April almost for a period of six months. Moreover financial year 2021-22 witnessed the COVID Pandemic due to which various activities came to halt. The Panchayat Pradhan of Byana and other villagers requested to re-construct the Bus stand so that it benefits local people. An amount of Rs. 9.06 Lakh was spent for re-construction of this bus stand. Payment of Rs. 8000/- was pending and after allotment of Budget the pending payment has been made. Now the villagers are very much happy and they appreaciated the efforts of NHPC.

1. सीएसआर के अंतर्गत केंद्रीय विद्यालय/ अन्य विद्यालयों के बाह्य विद्यार्थियों पर व्यय /Expenditure on Kendriya Vidyalaya/ Other Schools for Outsiders – CSR

धौलीगंगा पावर स्टेशन द्वारा अपने सामाजिक उत्तरदायित्व के निर्वहन तथा सामाजिक उत्थान हेतु वर्ष 1998 में पावर स्टेशन के निगालपानी परिसर में केंद्रीय विद्यालय की स्थापना की गई। इस विद्यालय में एनएचपीसी कार्मिकों के बच्चों के अतिरिक्त स्थानीय लोगों के बच्चे भी शिक्षा ग्रहण करते हैं। इस विद्यालय में बाह्य विद्यार्थियों की शिक्षा पर होने वाला व्यय उनकी संख्या के आधार पर आनुपातिक रूप से सीएसआर एवं एसडी मद में बुक किया जाता है। वर्ष 2021-22 में उक्त मद में कुल 256.97 लाख रुपये का बजट आवंटित किया गया था जिसके सापेक्ष कुल 253.83 लाख रुपये खर्च हुआ है। वर्तमान सत्र में केंद्रीय विद्यालय, धारचूला में कुल 545 विद्यार्थी शिक्षा ग्रहण कर रहे हैं जिनमें से बाह्य विद्यार्थियों की संख्या 499 है।

3. राजकीय इंटर कॉलेज, खेत, तहसील धारचूला, जिला पिथौरागढ़ (बाँध के समीप) में सीएसआर एवं एसडी के अंतर्गत प्रेक्षागृह (ऑडिटोरियम) का निर्माण / Construction of Auditorium at Government Inter College, Khet (near Dam Site) –

धौलीगंगा पावर स्टेशन के बांध स्थल, छिरकीला के समीपवर्ती ग्राम खेत में राज्य सरकार द्वारा एक इंटर कालेज स्थापित है। पावर स्टेशन के सम्पूर्ण जलग्रह (catchment) क्षेत्र व दारमा घाटी में स्थापित यह एक मात्र इंटर कॉलेज है। वर्तमान में इस कॉलेज में पूरी घाटी के दुर्गम क्षेत्र में स्थित गाँवों के निर्धन/ मध्यमवर्गीय परिवारों के कुल 154 छात्र/ छात्राएं अध्ययनरत है। वर्ष 2013 में उत्तराखंड में आई प्राकृतिक आपदा में इस कॉलेज की तीन इमारतें क्षितग्रस्त हो गई थीं। कक्षाओं के लिए कमरों की कमी होने से पठन-पाठन के कार्य में असुविधा होने लगी जिससे इन ग्रामों से पलायन कर लोग आस-पास के कस्बों में जाने को बाध्य हो गए। आपदाग्रस्त इस कॉलेज में स्थान की कमी होने के कारण कॉलेज प्रशासन द्वारा एनएचपीसी से एक ओडिटोरियम निर्माण का अनुरोध किया गया तािक बच्चों को सामूहिक रूप से भी पढाया जा सके। कार्य के महत्व व आवश्यकता को देखते हुए एनएचपीसी द्वारा ऑडिटोरियम निर्माण का कार्य किया जा रहा है। इस कार्य से जहां इस वर्ष के 154 बच्चों को लाभ होगा वहीं कार्य के जीवन पर्यंत तक 7700 से अधिक बच्चे लाभान्वित होंगे साथ ही ग्रामों से पलायन भी रुक पाएगा। इस कार्य में कुल 9.59 लाख रुपये की लागत आई है।

यह गतिविधि वर्ष 2019-20 में स्वीकृत की गई थी, जिसे वर्ष 2020-21 तक पूर्ण किया जाना था किंतु कोविड-19 की परिस्थितियों के कारण यह गतिविधि वर्ष 2021-22 में पूर्ण हुई। इस गतिविधि को पूरा करने के लिए वर्ष 2021-22 में रुपये 6.09 लाख का बजट प्रावधान रखा गया था जिसके सापेक्ष कुल व्यय रुपये 5.61 लाख हुआ है।







The "Sikkim Building Construction Regulations, 1991" regulates all building construction activities within the notified urban areas of the state and based on which Blue Print Plans are approved by the Government. While allowing the constructions; mandatory guidelines / instructions are issued to be followed by the individual/ agency for carrying out such constructions. However, instances have come to the notice of the Department that in several cases, constructions are being carried out duly violating the guidelines and causing damages / obstructions to the public infrastructure, such as roads, drains, footpath, jhoras etc. There is every chance that such actions may lead to disasters in the form of landslide, flash floods, damages to the environment etc. The urban areas with dense habitation and intrusive change of topography are at greater risk of these natural calamities. It is also found that construction materials and household wastes are obstructing the public drains / jhoras, roads and footpath contributing to natural calamities and inconveniencing the public in general.

In view of this, the public in general are hereby advised/reminded to observe the following instructions issued by the Department while carrying out construction works:-



Under Swachh Vidyalaya Abhiyan, the Project constructed 3129 nos. Toilets in 14 Districts of Assam and 04 districts of Arunachal Pradesh. Now, as per directions of MoP, the Project is taking up the repair of 2937 nos. Toilets (192 nos. Toilets

have been abandoned). The Project is taking up the repair works through respective District Education Department / Bodies. Till FY 2021-22, the Project signed MOU for repair of 2858 nos. Toilets with 17 districts. MOU for repair of 79 nos. Toilets are yet to be taken up (42 Nos. Toilets with West Siang District, Arunachal Pradesh and 37 nos. Additional Toilets with Majuli District Assam) due to various reasons. Till FY 2021-22, reports of completion of the repair works of 640 nos. Toilets has been received. Total Expenditure including 5 years maintenance incurred on this activity is Rs. 6,22,55,929/- (Rupees Six Crore Twenty Two Lakh Fifty Five Thousand Nine Hundred Twenty Nine Only) and has been completed on 08 December 2021.

SECTOR – HEALTH CARE AND SANITATION

 CSR support towards setting up of one no. PSA Oxygen Generation plant in the Campus of District Hospital, Siddharthnagar, UP

In view of emergent situation of covid-19, District Administration of Siddharthnagar requested for installation of 570 LPM oxygen generation plant at campus of District hospital to provide better treatment to the patients living in area of Siddharthnagar district. Acordingly, NHPC has allocated the fund of Rs. 50.0 lac for setting up the Oxygen generation plant of 570 LPM Capacity at District Hospital, Siddhartnagar and an MOU was signed on 28.05.2021 with District authority, Siddharthnagar. Plant has been commissioned & dedicated to Nation on 07.10.2021. Oxygen is being supplied to 50 isolation beds and 20 nos ICU beds of the District Hospital.

The Test Run was successfully completed and Dr. Anup Yadav & Team of Siddharthnagar, Hospital were provided the training for operations /essential checks.





 Supply, Installation, Testing and Commissioning of 1 no. PSA Oxygen Plant of 1000 (+/- 5%) LPM with booster having cylinder filling facility at B K Hospital, (District Hospital/ Government Hospitals) Faridabad along with hands on training.

In view of upsurge in covid cases and sudden increase in requirement of oxygen to Covid patients, NHPC Ltd was directed that one Oxygen Generation plant shall be installed in Govt. Hospital at Faridabad. Accordingly, a purchase order for an amount of Rs.163.03 lac was placed to M/s Spirare Energy Pvt. Ltd after completing all the formalities for Supply, Installation, Testing and Commissioning of 1 no. Oxygen Plant of 1000 (+/- 5%) LPM with booster having cylinder filling facility along with provision 320 KVA DG set at B K Hospital. Implementation of this CSR activity was carried out by NHPC Ltd through tendering process. Total Project cost of this activity is Rs. 212.06 lakh.

The Oxygen Generation Plant was inaugurated and dedicated to the nation on 07.10.2021, further handed over to Hospital Authority for running and maintenance of the plant.
