Sirs/ महोदय,

This is with reference to clarification sought from the Company regarding recent news item which appeared in the "myrepublica.nagariknetwork.com" dated March 17, 2023 captioned "Indian company NHPC Ltd permitted to carry out study of 450 MW Seti River-6 Hydropower Project".

Our point-wise reply to clarification sought is as follows:

- a) Whether such negotiations/events were taking place? If so, you are advised to provide the said information along with the sequence of events in chronological order from the start of negotiations/ events till date.

**Reply:** Yes, the Company had vide letter dated 18.08.2022 (**copy enclosed**) already informed the stock exchanges regarding signing a Memorandum of Understanding (MoU) with Investment Board Nepal (IBN), Govt. of Nepal for preparation of Detailed Project Report (DPR) and development of two hydropower projects namely West Seti (750 MW) and Seti River 6 project (450 MW) in Nepal.

As per the MoU, the preliminary study for preparation of Inception Report followed by Detailed Project Report (DPR) will be carried out by NHPC, which is anticipated to take substantial time of 2-3 years for establishing the viability and feasibility of the projects.

- b) Whether you/company are aware of any information that has not been announced to the Exchanges which could explain the movement in the trading, if any? Further, you are advised to provide the said information and the reasons for not disclosing the same to the Exchange earlier as required under regulation 30 of the SEBI (LODR) Regulations, 2015.
