## I. Preamble:

NHPC Limited is committed to achieve its goals of fair business practices by integrating various Govt. Regulations, Orders, CVC Guidelines and environmental friendliness of products and services into its supply chain decision making.

The main objectives of this policy are enumerated hereunder:

- To achieve uniformity in procurement norms, standards, policies, procedures, practices and guidelines among Contracts Divisions of the corporate office and projects/power stations of NHPC besides improving transparency and public accountability.
- ii) To enhance professional competence and negotiating skills of personnel handling procurement functions.
- iii) To effect all procurement within the prescribed lead time so as to obviate time and cost over runs.
- iv) To promote compliance with the policy of the Government of India.
- v) To ensure strict adherence to Quality Standards and Technical Specifications.
- vi) To maintain close co-ordination with the Contractor to build on a sustainable basis Employer Contractor relationship with a view to enhance the confidence.
- vii) To ensure that the payments due in terms of provisions of the contract are released to the Contractor in time.
- viii) To ensure that purchasing decision achieve the best overall value.
- ix) To ensure that all procurement is carried out consistently and equitably to ensure open and effective competition.
- x) To ensure that the public money be spent efficiently and effectively in accordance with the applicable government policy.



xi) To ensure Procurement policies, practices and procedures are transparent.
