

## **March 2013**

- NHPC has signed Memorandum of Understanding (MoU) for the year 2013-14 with Ministry of Power, Government of India on 25.03.2013. The MoU was signed by Shri P. Uma Shankar, Secretary (Power), Government of India and the Chairman & Managing Director, NHPC Ltd. in the presence of senior officers of the Ministry of Power and NHPC. A challenging target of generation of 22300 MUs of energy has been set for the Company as against 20550 MUs set for the 2012-13. The Gross Sales has been kept as Rs. 5410 crore against Rs. 4747 crore kept for corresponding previous year.
- Mechanical Spinning of all Four Units of Uri-II H.E Project (Unit-1 on 29.03.2013 and Units 2, 3 & 4 on 30.03.2013) was successfully achieved.
- Unit # 4 (4th Unit) of Teesta Low Dam-III H.E Project has been successfully synchronized on 31.03.2013 and subsequently tested at full load.
- All the Civil works and Reservoir filling upto Minimum Draw Down Level (MDDL) of Parbati-III Hydroelectric Project has been completed.
- Public Hearing of Dibang Multipurpose Project was conducted at Lower Dibang Valley, Roing and Dibang Valley, New Anaya on 11.03.2013 and 13.03.2013 respectively.
- Shri R.S. Mina, Director (Personnel), NHPC has been elected as the President of Power HR Forum and also elected as a Member of the Executive Board of Standing Conference on Public Enterprises (SCOPE).
- NHPC has executed Term Loan Agreement of 15 years with State Bank of India and State Bank of Hyderabad for Rs.1000 crore and Rs.500 crore respectively on 25.03.2013 for meeting the debt requirement of ongoing projects.
- NHPC has been certified with SA 8000:2008 certificate for upholding Social Accountability standard.
- Meeting of all Rajbhasha Officers was organised at Corporate Office on 14th and 15th March 2013 which was inaugurated by famous literary figure, Dr Ramdarash Mishra. Likewise, the valedictory session was addressed by another stalwart of Hindi Literature, Shri Dr. Ganga Prasad Vimal. Shri R.S. Mina, Director (Personnel), NHPC was present on both the occasions.
- NHPC won the Team Championship at the 17th Inter CPSU Badminton Tournament held at Chamera-I Power Station, Chamba, Himachal Pradesh from 12th to 15th March 2013.
- NHPC Women Team emerged as champions in Pragati-2013: A Women Quiz conducted by All India Management Association (AIMA) held on 09.03.2013 in New Delhi.

## **February 2013**

- The International Court of Arbitration at Hague on 18th February 2013 upheld India's right to divert water for the 330 MW Kishanganga Hydroelectric Project of NHPC. The award of the International Court of Arbitration has allowed India to divert water from the Kishanganga River for power generation by the Project in the manner envisaged. The work is progressing in full swing and we shall make all efforts to commission the Project on schedule.
- The 3rd Unit (Unit#3) of Teesta Low Dam Project-III has been successfully synchronized with grid on 24.02.2013.
- MOEF has accorded Stage-I (in principle) Forest Clearance to 520 MW Teesta-IV Hydroelectric Project vide their letter dated 26.02.2013.
- Tanakpur Power Station has achieved the excellent generation target of 456 MUs on 25.02.2013.
- Meeting of the Consultative Committee of Members of Parliament for the Ministry of Power chaired by Shri Jyotiraditya M. Scindia, Hon'ble Minister of State for Power (Independent

Charge) was held on 12.02.2013 in New Delhi, wherein issues pertaining to NHPC were discussed.

- Shri R.S. Mina, Director (Personnel) has been honoured with the HR Leadership Award instituted by Institute of Public Enterprise (IPE). He has also been recognized as one of the '50 Most Talented HR Leaders in PSU' at the 21st edition of World HRD Congress on 16.02.2013. Besides, Governing Body of Power HR Forum, the umbrella body of Public Sector Undertakings in the Power Sector, elected Shri Mina as its new President in its 14th Governing Body Meet held at Chandigarh on 11.02.2013.
- Ms A. Nalini, Accounts Officer, Commercial Division, Corporate Office has won the 3rd Prize in 'Best Women Employee Award' instituted by Women in Public Sector Undertakings (WIPS). The award was presented during the 23rd National Meet of WIPS held in New Delhi on 12th-13th February 2013.
- Akhil Bharatiya Kavi Sammelan was organized on 15.02.2013 in NHPC Residential Complex, Faridabad to promote and propagate Hindi, wherein renowned Hindi Poets presented their poetic compositions in an august gathering of employees and their family members. The Kavi Sammelan was inaugurated by Shri R.S. Mina, Director (Personnel).
- A computer workshop for member offices of Town Official Language Implementation Committee was organized at Faridabad on 27.02.2013, wherein participants were trained in Hindi typing through Unicode software. Important information regarding rules relating to official language was also given to the participants. NHPC is the convener of the Committee presently.
- All the Power Stations of NHPC together cumulatively generated 17670 MUs of energy up to February 2013.

## **January 2013**

- NHPC has signed Implementation Agreements with Government of Uttarakhand on 23rd January 2013 for 210 MW Dhauliganga Intermediate and 120 MW Goriganga-IIIA H.E. Projects located in Pithoragarh District, Uttarakhand. The projects are to be done on BOOT basis by NHPC with an agreement period of 45 Yrs. Discussions have also been initiated for taking up more hydropower projects with the State on Joint Venture basis.
- During January '13, NHPC added 77 MW in its installed capacity. With this capacity addition, 341 MW has been added in current financial year which has increased our total installed capacity to 5636 MW. Two units (Unit # II and Unit # I), 33 MW each of TLDP-III have been commissioned on 20.01.2013 and 30.01.2013 respectively and Last unit (Unit # IV, 11 MW) of Chutak Power Station has also commissioned on 28.01.2013.
- The Inspection on Official Language of Corporate Office was conducted on 12.01.2013 by the Second Parliamentary Sub-Committee on Official Language. Dr. Prasanna Kumar Patasani, Hon'ble Member of Parliament was Convener of the Committee. The Committee reviewed the implementation of Rajbhasha in the Company and they were satisfied with the progress of Rajbhasha in the Company.
- Second Unit (Unit # II, 15 MW) of Nimoo Bazgo Project has been synchronized at available load on 20.01.2013.
- In Uri-II Project Diversion Tunnel plugging activities completed on 25.01.2013.
- MOEF has accorded Environmental Clearance to 66 MW Loktak Downstream Hydroelectric Project vide their letter dated 16.01.2013.
- The MoU Target of CFD Analysis of Penstock / Pressure Shaft, Surge Shaft and part of HRT of Dhauliganga Power Station has been achieved in January 2013 with Excellent rating.

- CERC vide Amendment issued on 31.12.2012 allowed additional 1% return on Equity (i.e. 16.5%) for the storage type generation stations including pumped storage hydro generating stations and run of river generating station with pondage.
- NHPC has funded construction of a Driving Test Range at Sector-12, Faridabad, Haryana as part of its Corporate Social Responsibility (CSR) activities. NHPC has provided financial assistance of Rs. 11.5 lakh for construction of the Driving Test range which is in the completion stage. The Driving Test Range is first of its kind in Faridabad.
- A meeting of Rajbhasha Officials of the Company held at Corporate Office under the Chairmanship of Shri R.S. Mina, Director (Personnel) on 30.01.2013, wherein progress of implementation of Rajbhasha was reviewed and important instructions were given for progress of Rajbhasha.
- All the Power Stations of NHPC together cumulatively generated 17004 MUs of energy up to January 2013.

## **December 2012**

- NHPC has registered the highest ever Net Profit after Tax of Rs. 2,772 crore and paid dividend of Rs. 861.06 crore to shareholders including Rs. 743.64 crore to Government of India for the FY 2011-12.
- In the capacity addition, NHPC has commissioned 264 MW which includes 231 MW Chamera-III and 33 MW (3x11) of Chutak Hydroelectric Projects. Besides, One Unit of 15 MW of Nimoo Bazgo Hydroelectric Project was synchronized at available load on 11.10.2012. Mechanical spinning of Unit Nos. II & I of TLDP-III Hydroelectric Project was also achieved on 20.12.2012 and 24.12.2012 respectively.
- In the area of technological advancements, by implementing Finance and associated modules in the balance 23 locations of NHPC, NHPC has now become 100% ERP enabled. NHPC has also been conferred a number of awards and recognitions for its commendable performance in various functional areas.
- NHPC has commissioned the second 66/11 KV Sub-station on 14.12.2012 as part of developing transmission network under RGGVY in Leh Distt, J&K; the day happens to be the New Year Day - Losar in Leh-Ladakh.
- Consultancy works of Renovation, Modernisation and Updating of Varzob Hydro Power Plant, Tazakistan was successfully completed by NHPC. Subsequently, the Plant was re-inaugurated on 28.12.2012.
- Board of Directors in its 354th meeting held on 12.12.2012 has accorded approval for signing Implementation Agreements for 210 MW Dhauliganga Intermediate and 120 MW Goriganga-III Hydroelectric Projects.
- The Board also approved setting up of Two numbers grid connected Solar Power Projects and Two nos. grid connected Wind Power Projects up to installed capacity of 50 MW each in India.
- NHPC bagged Two prizes in the Inter Organisation Paper Presentation Competition Quest for Excellence (Q4E) organized by Power HR Forum on 21.12.2012. NHPC Team won 'Special Jury Prize' and 'Best Young Presenter (Female) Award'.

## **November 2012**

- 38th NHPC Raising Day was celebrated on 7th November, 2012 with all pomp and glitter throughout the Company. The function at Corporate Office was organized at Siri Fort Auditorium, New Delhi. Shri P. Uma Shankar, Secretary (Power), Government of India graced the occasion as Chief Guest. A sparkling performance by famous playback singer, Ms Alka Yagnik, and traditional dance forms by children from the various locations made the evening

lively. A large number of dignitaries and NHPC employees along with their family members were present on the occasion.

- Generating Units Nos.II, III & I of Chutak Hydroelectric Project have been declared commissioned on 08th, 11th & 22nd November 2012 respectively. NHPC contribution towards capacity addition is 264 MW which is 79% of the hydro capacity addition in the country during the current year.
- NHPC has been adjudged winner in recognition for 'Largest Hydro Generating Capacity in Public Sector' at India Power Awards 2012. The Award was presented by Council of Power Utilities at New Delhi.
- NHPC Limited has been conferred with the 'IPE Corporate Governance Award' for its exemplary initiatives in the area of Corporate Social Responsibility (CSR). The award is the result of continuous monitoring of the CSR activities by a jury of academicians, social scientists and eminent personalities.
- NHPC along with other power PSUs under Ministry of Power has been conferred with the Silver Medal for 'Excellence in display' under the Ministries and Departments Pavilion category at the 'India International Trade Fair (IITF) 2012' held at New Delhi from 14 - 27 November 2012.
- Hon'ble Prime Minister of Bhutan, Lyonchhen Jigmi Y Thinley visited District Zhemgang, Bhutan and Chamkharchhu-I HE Project area from 21.11.12 to 23.11.12. ## **October 2012**

- All the Power Stations of NHPC together cumulatively generated 15073 MUs of energy up to Oct'12.

## **August 2012**

- NHPC has registered net profit of Rs. 669.81 crore and sales turnover of Rs. 1,399.12 crore during the 1st quarter of the current financial year against net profit of Rs. 791.05 crore and sales turnover of Rs. 1,431.41 crore earned during corresponding period of the previous year.
- Initial reservoir filling of Nimoo Bazgo HE Project has been achieved. The reservoir filling started on 02.07.2012 and completed upto MDDL (EL 3090m) on 09.08.2012. This challenging task was achieved well within the schedule as the reservoir filling was to be completed by 20th August 2012.

## **May 2012**

- The Annual Press Conference on the financial results for the FY 2011-12 was held on 25.05.2012 at New Delhi and Investor / Analyst Meet were held at Mumbai on 28.05.2012.
- The cumulative power generation of all NHPC power stations stands at 3728 MU against a target of 3762 MU up to the month of May 2012.
- The World Environment Day is being observed on 5th June 2012 with UN theme "Green Economy: Does it include you?"
- NHPC Limited has been awarded the 'Best Performing Generation Company (Hydro)' at Power Line Awards 2012. The CMD, NHPC received the award from Shri Sushilkumar Shinde, Hon'ble Union Minister of Power during the Power Line Awards 2012 held at New

Delhi on 15th May 2012. The prestigious Power Line Awards recognizes excellence and outstanding performance in the Indian Power sector in the fields of generation, transmission and distribution.

- The Parliamentary Second Sub-Committee on Official Language under the chairmanship of Dr. Nirmal Khatri, Dy. Chairman of Parliamentary Committee on Official Language, reviewed the progress of Rajbhasha related work of Teesta Low Dam –IV Project at Darjeeling (West Bengal) on 31.05.2012. The Committee held discussions with the CMD, NHPC and Director (Personnel) on the status and various issues pertaining to implementation of Rajbhasha in NHPC. Detailed presentation made by NHPC was appreciated by the members of Committee.
- Board of Directors in its meeting held on 25.05.2012 adopted the audited financial results for the year ending 31.03.2012. During the FY12, NHPC has registered highest ever net profit (after Tax) of Rs. 2,771.77 crore (PY: 2166.67 Cr) and all time high sales turnover of Rs. 5,509.65 crore (PY: 4046.59 Cr). NHPC power stations generated highest ever 18683 MUs of electricity during the year (PY: 18606 MUs). NHPC has also proposed a final dividend of 7% (Rs. 0.70 per share) for the FY11-12 (PY: 6%).

### **Performance Highlights During 2011-12**

- Achieved highest ever Net Profit after Tax of Rs. 2771.77 crore which is 27.93 % higher than the net profit after Tax of Rs 2,166.67 crore earned during 2010-11.
- Registered Sales Turnover of Rs. 5509.65 crore as against Rs 4,046.59 crore of last year.
- Achieved Cumulative sales realization of Rs. 4,415 crore against Rs 3,619 crore achieved during last year.
- Generated 18683 Million Units (MUs) against the target of 18500 Million Units for “Excellent” MoU rating. In 2010-11, the Company had achieved a generation of 18606 MU
- NHPC has proposed a final dividend of Rs. 0.70 for the FY11-12. NHPC paid a dividend of Rs 738.04 crore to shareholders @ Rs 0.60 per equity share including Rs. 637.40 crore to the Govt. of India for the financial year 2010-11.
- During the FY 2011-12, NHDC (A joint venture between NHPC and Govt. of Madhya Pradesh) generated 4663.68 MU against MOU target of 3200 MU. The net profit of the Company was Rs. 646.90 crore and the Company has proposed to pay a dividend of Rs. 58.80 crore to its shareholders.
- GOI has conveyed its approval for change in object clause 1a) of Memorandum of Association of NHPC which inter-alia allows NHPC on its own to plan, promote and organize an integrated and efficient development of power in all its aspects through conventional and non-conventional sources in India and abroad.
- M/s Chenab Valley Power Projects (Private) Limited” has been incorporated on 13.06.2011 for development of Pakal Dul and other hydroelectric projects in J&K with an aggregate installed capacity of 2120 MW with equity participation of 49% (NHPC), 49% (JKSPDC) & 2% (PTC).
- Memorandum of Understanding (MOU) signed on 21.07.2011 with Orissa Hydro Power Corporation Limited (OHPC) and Government of Odisha for setting up a Joint Venture Company with OHPC (NHPC 51% and OHPC 49%) to develop hydropower projects in Odisha,
- Memorandum of Understanding (MoU) signed with Russia’s largest power generating company JSC RusHydro on 23.05.2011 for cooperation in the field of hydropower development, renewable energy sources and other areas of power generation
- The wet spinning of all the three units of Chamera-III has been completed successfully on 04.3.2012 and 05.3.2012.

- During 2011-12, two units (11 MW each) of 44 MW Chutak HE project in J&K was synchronized at partial load due to non-availability of full load
- Public Hearing of 66 MW Loktak Downstream HE Project has been conducted on 07.6.2011
- Public Hearing of 520 MW Teesta-IV HE Project has been conducted on 29.3.2012.
- NHPC has prepared and submitted DPRs of 1200 MW Tamanthi HE Project in Myanmar and 770 MW Chamkharchhu-I HE Project in Bhutan.
- NHPC was able to restore generation from Teesta-V and Rangit Power Stations within 6-8 hours of the devastating earthquake that struck West Bengal & Sikkim on 18.9.2011. Major structures at NHPC Power Stations and Projects in these States were safe although damages had occurred to some buildings and roads.
- NHPC presented a cheque of Rs. 7 crore to the Hon'ble Chief Minister of Sikkim, Dr. Pawan Kumar Chamling on 02.12.2011 as a contribution to the "Chief Minister Relief Fund" for the benefit of victims of earthquake which had hit Sikkim 18.09.2011.
- NHPC has undertaken a number of community development initiatives under CSR and spent about Rs.10 crore during 2011-12. - Prepared DPR towards development of wind power project near Salal Power Station in Bidda, J&K.
- Teesta -V Power Station has been validated under VCS mechanism of Verified Emission Reduction (VERs) Scheme.
- Electrified 460 UE/DE villages and provided connections to 1.9 lacs BPL households. 2020 PE villages have also been intensively electrified during the year.
