January 2014

- Memorandum of Understanding for development of wind energy projects by NHPC in Kerala was signed between NHPC and Govt. of Kerala on 6.01.2014 at Thiruvananthapuram. NHPC will develop grid interactive wind power project in Nallasingam and Kottathara sites in Pallakad district with a potential of 82 MW capacity.
- NHPC got the distinction of being the first among the CPSUs to undertake buyback of its equity shares. NHPC has received appreciation from Department of Disinvestment, Ministry of Finance, Govt. of India for successful completion of the buyback whereby Govt. of India has received an amount of Rs.2131.28 crore as proceeds of consideration against the shares purchased by the Company.
- The Board of Directors in its meeting held on 31.01.2014 has adopted the unaudited financial results for the quarter ended 31.12.2013 with net sales of Rs.1123.38 crore and a net profit of Rs.259.35 crore
