

As on March 2016

- Unit # 2 of TLDP- IV H.E. Project has been put under commercial operation w.e.f. 00:00 hrs of 31.03.2016.
- CMD NHPC, addressed the inaugural session of 5th Sustainable Environment Forum 2016 organized by ASSOCHAM on 16.03.2016 in New Delhi in the presence of Shri Y.S. Chowdhary, Hon'ble Minister of State, Ministry of Science and Technology and Earth Sciences, Govt. of India and His Excellency Dr. Linus von Castlemur, Ambassador of Switzerland to India and Bhutan.
- NHPC paid an interim dividend of Rs. 875.49 crore to Govt. of India for the financial year 2015-16. The dividend payout was presented to Shri Piyush Goyal, Hon'ble Minister of State (Independent charge) for Power, Coal and New & Renewable Energy, Govt. of India on 18.03.2016.
- CMD NHPC, met with Shri Virbhadra Singh, Hon'ble Chief Minister of Himachal Pradesh at Shimla on 22nd March 2016 and appraised him on the progress of Parbati-II H.E. Project (800 MW) and performance of the completed projects of NHPC in the state.
- Shri Balraj Joshi has been appointed as Director (Technical) and he has taken charge of the office from 1st April 2016. NHPC best wishes to him for his new assignment. Shri D.P Bhargava, Director (Technical) superannuated on 31.03.2016. NHPC wishes him and his family a happy retired life.
- Total cumulative power generation of all NHPC power stations during this Financial Year stands at 23679 MU against the "Excellent Target" of 22000 MU. This is the highest ever generation by NHPC.
- Swachh Bharat Abhiyan is being observed from 14th March to 2nd April 2016. NHPC employees have pledged to devote 100 hours in a year at an average of 2 hours per week towards maintaining cleanliness.
- NHPC Women's Team won the 20th Inter CPSU Badminton Tournament while NHPC Men's team emerged as Runner up.
- NHPC hosted the 21st Inter CPSU Chess Tournament under the aegis of Power Sports Control Board (PSCB) from 16th to 18th March 2016 at NHPC Residential Colony, Faridabad. The tournament drew participation from power sector PSUs/organisations like NHPC, DVC, PFC, NEEPCO, BBMB, PGCIL, MoP, THDC, CEA and REC.

As on February 2016

- Mechanical spinning of Unit # 1 of TLDP-IV (4 x 40= 160 MW) has been successfully achieved on 28.01.2016.
- NHPC was invited to the 13th Annual Conference on Hydropower in India- Best practices from Project Implementation to Operation & Maintenance, organized by India Infrastructure Publishing on 20.01.2016 at New Delhi, wherein CMD delivered a keynote address highlighting core competencies and achievements of NHPC and challenges being faced in implementation of hydropower projects were stressed upon.
- A two day international workshop titled 'Best Practices for Sustainable Hydro Development' was organized by NHPC alongwith Ministry of Power and High Commission of Canada in association with Central Board of Irrigation and Power (CBIP) from 21st to 22nd January 2016 at New Delhi. The workshop deliberated on best practices in successful implementation of hydro projects while balancing environmental, community, social and economic factors. The workshop had experts from India, Canada and neighbouring countries and drew participation from leading Government and private organizations.
- The cumulative power generation of all NHPC Power stations stands at 21460 MU against the Excellent target of 19746 MU up to the month of January 2016.

As on January 2016

- NHPC has achieved 20670 MU of cumulative generation on 31.12.15, which surpasses the MoU target of 19063 MU (till Dec'2015) under Excellent Rating.
- The half year ended 30.9.2015, NHPC registered a 50% increase in net profit by earning Rs. 1948 crore as against Rs. 1300 crore earned during 1st half of FY 2014-15.

September 2015

August 2015
