

Highlights of March 2019

- In FY 18-19, NHPC has achieved its highest ever annual generation of 24193 MU.
- The Expert Committee constituted for resolution of various issues at Subansiri Lower, by MOEF with the directions of Hon'ble NGT has also submitted its report.
- NHPC has paid an interim dividend of Rs. 526.53 crore to Govt. of India for FY 2018-19 on 6th March 2019.
- NHPC was appointed as Aggregator under Pilot Scheme-II by Ministry of Power for procurement of aggregated power of 2500 MW for 3 years through the nodal agency PFC Consultancy Limited.
- 7th Customer meet for beneficiaries of Northern region in Goa was organised from 1st to 3rd March 2019.
- 40th TCC & ERPC meet was hosted by NHPC at Jodhpur on 15th & 16th March 2019. Memorandum of settlement on wage revision of workmen w.e.f. 01.01.2017 was executed between Management and Workmen Unions on 25.03.2019.

Highlights September 2018

As per the MoU, both organisations will cooperate in joint bidding for consultancy works and hydroelectric projects, wherein, NHPC shall be responsible for civil Works and hydro mechanical works and BHEL shall be responsible for electro-mechanical works.
- The 42nd Annual General Meeting of the Company was successfully held on 27th September 2018 at Corporate Office, Faridabad.
- NHPC Power Stations generated 2743.7 MUs in the month of September 2018.

Highlights August 2018
