## Dear Colleagues,

As an organization and as a team we are committed to achieve international standards in the field of sustainable power generation. Whereas, we have been consistently heading towards our strategic goals, we need to focus on growth of the organization so as to keep pace with the vision of Government of India as well with the developments taking place in the power sector.

I am glad to share that the first month of year 2023 has been full of important events and activities for the corporation. I, alongwith Director (Projects), visited 2000 MW Subansiri Lower HEP from 03.01.2023 to 04.01.2023 and took a comprehensive review of the progress of works at the Project. I am happy to see the zeal and hard work being put by the team Subansiri. I am confident that the target of commissioning 2 units shall be achieved as per schedule. There has been significant progress at various fronts of the Project during the month. The concreting works of TRC started on 03.01.2023 in my presence. The civil works of 7 out of 8 Intake structures stand completed with the completion of slab at EL 210m of Intake #7. Important E&M works like Spiral Case Erection of Unit-3 have been started and the Lower Bracket Assembly of Unit-2 weighing 85T which will hold 630T Rotor Assembly was also successfully placed in generator pit on 19.01.2023.

Shri Y.K. Chaubey, Director (Technical)/ Director (Personnel), NHPC and CEO, BSUL met Shri M.K. Gupta, Additional Chief Secretary, Energy and Additional Sources of Energy, Government of UP on 03.01.2023 at Lucknow regarding Global Investor Summit 2023 and discussed future investment plan for BSUL's Solar projects/parks.

- The Committee on Public Undertaking held a meeting on "Corporate Governance in CPSU's" on 09.01.2023 at Chennai with NHPC Ltd and other Power PSU's.
- NHPC won 2 Golds, 1 Silver and 1 Bronze Medal in various categories during 27th Inter CPSU Badminton Tournament (9th-13th January 2023) organized under the aegis of PSCB, Ministry of Power, Government of India at Thyagaraj Stadium, New Delhi.
