As the excavation of HRT was nearly in completion, it was necessary to re-check / revalidate the stability of the existing ground control control points of SOI located near the Adit portals of HRT face -3 and face-4 with latest DGPS (Differential Global Positioning System) /GNSS. Latest DGPS shall increase the level of accuracy and precision and minimize the error . In this context the project requested Project Investigation Division (PID) ,C.O. to reaffirm the control point of SOI with latest DGPS survey instruments vide e-IOM No. NH/PARBATI-II/Geology/2023/17 dated 24.06.2023. In reply , PID vide e-IOM No. NH/CO/Project Investigation Division/2023/426 dated 26.06.2023 expressed their inability to conduct this survey as the older DGPS set with which they have worked before were not reliable and procurement of new DGPS was in process which would take some time .PID advised to do this survey work at project level itself. As the project did not have requisite instruments (DGPS/GNSS Receiver) to carry out the above work, this division approached SOI Dehradun to conduct this survey at earliest as part from SOL, no other government agency was doing this kind of specialized work. Citing mandate of National Geospatial policy dated 16.12.2022, SOI expressed its inability to carry out the above survey work and advised to carry out above work through outsourcing to private entities.  2. Consequently ,3 quotations were collected and M/s Innovative Solutions Pvt. Ltd. Declared as L1. Accordingly, the case was accorded approval from competent Authority as per DOP Section I SI No. 26A (ii) HOP not the below the rank of GM for conducting the above survey work.
