Accordingly M/s Megger India PVT Ltd. i.e. OEM of the BDV kit was contacted for providing budgetary offer for troubleshooting and rectification of the fault. M/s Megger India Pvt Ltd has informed that its channel partner M/s Clear Point instrumentation Pvt Ltd. shall execute the work. Further, on preliminary troubleshooting done vide telephonic conversation, M/s Clear Point instrumentation Pvt Ltd. has informed that issue of the BDV kit persists due to either problem in mother board or due to issue in HV transformer. However troubleshooting of exact fault can be possible only on physical inspection of the item.
