Due to rock mass movements on account of overburden pressure as well as rock crust adjustments owing to frequent earthquake phenomenon, Cavity was formed at several places in side wall of MIV Hall adjoining Machine Hall side. Loose falls & widening of cracks in side wall were also observed often. These were required to be treated on priority basis to protect Plants & Equipment's installed in MIV Hall and also for safety of manpower involved in operation and repair & maintenance works. In view of above reasons, the work was required to be taken up on urgency. Due to rock mass movements on account of overburden pressure as well as rock crust adjustments owing to frequent earthquake phenomenon Cavity was formed in side wall of Adit near to Pressure Shaft bottom, loose falls from crown level, widening of cracks in nearby area were also observed etc. Any further deterioration and widening of cavity may lead to collapse of crown and this may eventually block the complete Adit. Hence, these were required to be treated on priority basis as this area is very near to Pressure Shaft Bottom and in proximity to Adit to MIV Hall. In view of above reasons, the work is required to be taken up on urgency.
