SCOPE OF WORK

The Safety Audit provides assurance that the existing safety framework/ management control ensures the compliance with safety and statutory requirements. The Safety Audit should be conducted in terms of Indian Standard (IS):14489:1998 and other statutory requirements in various legislations, Acts, Rules, Standards, Cod of Practices, etc.

The Fire & Safety risk areas/ system should be physically checked/ examined whether the protection measures installed in the area/ system are operational/ healthy and adequate in reference to established statutory requirements in various legislations, Acts, Rules, Standards, Code of Practices, etc.

The Scope of work includes all safety aspects of the Power Station/ Project and limited to the following:

The firm shall also impart training to the employees at Power Station/ Project, after safety audit, for two days in each year on safety awareness. The training shall cover basics of fire safety and Accident Prevention, usage of first aid & PPE's, emergency procedures including shock treatment, use of firefighting equipment's, safety precautions while handling electro-mechanical equipment's, emergency response during crisis etc.. NHPC Ltd. shall facilitate the training programs to the extent of providing the venue for training, Board, photocopy of training material, food etc. The firm shall provide faculty for imparting training.

The Power Station/ Projects may raise queries/ seek clarifications on the safety audit report, statutory provisions, and requirements etc. after completion of safety audit/ training etc. upto one year. The Firm shall submit the reply of all queries/ clarifications etc. raised by the Power Station/ Project within 7 days.



SPECIAL CONDITIONS OF CONTRACT

The following special conditions shall be read in conjunction with the corresponding relevant provisions made in the Conditions of Contract and in case of any discrepancy or variation or contradiction between them, the provisions made under these Special Conditions of Contract shall prevail.

- 1. All the activities implemented in Sewa-II Power Station, must be in compliance with the requirements of ISO: 9001 (2015), ISO: 14001 (2015) & OHSAS 18001:2007.
- 2. The persons engaged for the work shall not divulge or disclose to any person of any details of office, operation process, technical know-how, security arrangements and administrative/organizational matters as all are confidential / secret in nature.
- **3.** The Power Station shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipment or vehicles of the engaged personnel.

4. Safety Audit Team:

Safety Audit team should consist of at least two number of qualified Safety Auditors of the Firm for the Safety Audit work (including training) of each Power Station/ Project.

5. Safety Audit And training Fees:

- i. The Safety Audit fee (including training) shall be including GST and all costs (except local conveyance, accommodation at Power Station/ Project, facilities to be provided for training program etc. mentioned at Para 5 (ii) (C.) below) incurred by the firm in carrying out the Scope of Work.
- ii. The following shall be provided by the Power Station/ Project at free of cost to the firm:
 - a) Local conveyance for completion of the work within the Power Station area.
 - b) Accommodation at Power Station to the Safety Auditors deployed for the completion of work at free of cost.
 - c) Facilitate for the training programs to the extent of providing the venue for training, projector, Board, photocopy of training material, food, etc.
 - d) Transportation from nearest railway stations i.e. Pathankot to Sewa-II power station Mashka is in scope of NHPC. Local conveyance at site shall also be provided by the NHPC. All other transportation charges shall be in the scope of the firm.
 - iii. All other expenses except stated above shall be borne by the firm.

6. No. of Safety Audits

All safety Audits shall be conducted in consultation with Engineer-in-Charge.

7. Payment terms

The payment to the Contractor/Firm shall be made after every visit on completion of scheduled audit visits and submission of audit report & Invoice. Income Tax (TDS) and other taxes as applicable if any shall be deducted at source.

8. Compliances/ Declarations/ Certificates by firm(s) on appointment

- i. The Safety Audit Firm shall not sub-contract the assigned Safety Audit work,
- ii. The Safety Audit team shall work in strict confidence and shall ensure that information in respect of the operation of the Power Station is dealt with in strict confidentiality and secrecy.

- iii. Neither the Safety Audit firm nor its partners(s) or associates should have any interest in the business of the company,
- iv. The Safety auditor shall ensure that data given to the Auditor by the company and any information generated from the data provided shall not be used by the Auditor for any other purpose.
- v. The Safety auditor undertakes to perform the Services with the highest standards of professional and ethical competence and integrity. The Safety auditor shall promptly replace any employees assigned under this Contract that the Client considers unsatisfactory.
- vi. The Safety auditor and his Personnel shall not, either during the term or within two (2) years after the expiration of the contract period, disclose any proprietary or confidential information relating to the Power Station, the Services, this Contract, or the Client's business or operations without the prior written consent of the Client.

9. Debarring provisions:

The Audit Firm will be debarred from getting, in future, the Safety Audit of NHPC Ltd.:

- i. If the Firm obtains the appointment on the basis of false information/ mis-statement
- ii. If the Firm does not take up audit in term so appointment letter.
- iii. If the Firm fails to maintain/ honour confidentiality and secrecy of the Company's safety data, safety statement and safety information.
- iv. If the Firm fails to comply with any of condition laid down in clause 5 above.

10. Submission of Audit Report:

The Firm should submit comprehensive Audit Report after the completion of job at site as per Accepted Professional Standard in printed form & as well as in soft copy (.pdf format).

The report must contain the basis of conclusion, calculations & necessary documentary support, and recommendations in respect of life/ fire/ electrical safety in conformity to relevant codes, standards, rules and regulations, identify gaps, if any, and recommend action plan and suggest improvements, rectifications, up gradation, if required, as per relevant codes, standards, rules and regulations etc.

If required, NHPC may raise any query/ clarification related to Audit Report, statutory provisions, standards, rules and regulations etc. The Auditor shall submit the reply of query/ clarification to NHPC within 7 days of its receipt.

11. Completion period

The completion period of the work of Safety Audit for three year:

The work of Safety Audit along with submission of report in hard and soft copy in accordance with scope of work and as per terms and conditions of contract have to be completed and conducted in consultation with Engineer-in-Charge.

- 12. Safety & Security & Insurance: Safety, security & insurance of men and materials of the contractor involved in the above work shall be the responsibility of the contractor only.
- **13. Dispute**: In case of any dispute arises during the execution of work/services, the same shall be referred to the Group General Manager, Sewa-II Power Station and whose decision in all such matters shall be final and binding for both the parties.
- 14. Scope of work: As per Annexure-A.
- 15. Engineer-In-Charge: GSM (safety division) shall be Engineer -In-Charge of this work.

Preface: Agreement representing a Service Level Agreement ("SLA" or "Agreement") between the Buyer and Service Provider has been uploaded in bid section. The purpose of the agreement uploaded is to facilitate implementation of Services intended by the Buyer. Each documents as uploaded by buyer should be read in totality to conclude the requirement of Custom e Bid floated on portal.

The Agreement uploaded in bid section will generally contain the Scope of Work, (SOW), stakeholder's obligations, Special Terms and Conditions (STC) related to service delivery as formulated by the Buyer and Payment Terms etc of the service for mutual understanding of the stakeholders. The Agreement remains valid till completion of Scope of Services or end of contractual duration (whichever is earlier) unless either superseded by a revised agreement mutually endorsed by the stakeholders or terminated by either of the parties thereof.

Guiding Principle: The Services contracts placed shall be governed by following set of Terms and Conditions:

- 1. General Terms and Conditions for Goods and Services;
- 2. Buyer's Formulated Service Specific STC including the Service Level Agreement (SLA) for the service as uploaded with the bid in form of suitable matching document,

The above terms and conditions are in reverse order of precedence .Service specific STC supersede GTC, whenever there are any conflicting provisions. The above set of terms and conditions along with scope of work and service level agreement as enumerated in the document shall be construed to be part of the Contract between Buyer and Service Provider.

Intended Objectives And Goals of SLA: The objective of Agreement (SLA) as uploaded in bid section is to ensure that all the commitments and obligations are in place to ensure consistent delivery of service to buyer by service provider. Generally The goals of an Agreement are to:

- 1. Provide clear reference to service ownership, accountability, roles and/or responsibilities of both parties
- 2. Present a clear, concise and measurable description of service offered to the buyer
- 3. Establish Terms and Conditions for all the involved stakeholders, it also includes the actions to be taken in case of failure to comply with conditions specified
- 4. To ensure that all the parties understand the consequences in case of termination of services due to any of the stated reasons
- 5. The agreement will act as a reference document that both the parties have understood the above-mentioned terms and conditions and have agreed to comply by the same. The agreement can also be revised/ modified on mutual consent of the stakeholders.

Parties To The Agreement

The main stakeholders associated with this agreement are:

- 1. Buyer: Buyer is responsible to provide clear instructions, approvals and timely payments for the services availed.
- 2. Service Provider: Service provider is responsible to provide all the required services in timely manner. Service provider may also include seller, any authorized agents, assignees, successors and nominees as described in the agreement

The responsibilities and obligations of the stakeholders have been outlined in this document. The document also encompasses service level /penalties in case of non-adherence to the defined terms and conditions. It is assumed that all stakeholders would have read and understood the same before signing the SLA document.

ADVISORY WITH RESPECT TO SCOPE OF SERVICE

Scope of Work (SOW) is the most important & crucial component of any bidding process. It is for this that the whole bidding process is entered upon to execute the scope of work and deliver outcomes that the Government strives for. Scope of work directly affects the performance of contract therefore utmost care should be taken to aboid ambiguity with respect to deliverable.

For example , in case of Complex / Intricate Consulting Services , Some key guiding principles for drafting scope of work may be as under:

- "Detailed" specification of requirements is extremely critical please ensure that even standard assumptions on scope of work are laid down and described .
- Make sure that specifications are endorsed by key stakeholders.
- Identify mandatory and non-mandatory requirements in scope of work · It should clearly provide the outcomes expected from solution/service delivery .
- The scope of work should mention what the outcome is based upon time or material?
- A check should be made that the final specification of requirements:(a) addresses the targeted outcomes and business objectives. (b)meets the agreed stakeholder needs (c) covers whole-of-life of the contract deliverables.
- The objective, structure and expected set of contents of each knowledge item/deliverable should be laid down, in as much detail as possible, rendering the best level of clarity to it.
- The coverage of services needed in the form of activities like client visits, geographies to be studied, stakeholder meetings / interviews / workshops to be conducted, must be detailed out to avoid delivery compromises.
- Buyer must ensure that the service provider complies with the Rule 144(xi) of General Financial Rules (GFR), 2017 and the product supplied, if any, must also comply with Make In India guidelines of DPIIT"

Important Note: Buyers authorities are advised to upload GAR report positively and without fail at appropriate place to ensure process complinace. Buyer may indicate about requirement Past Experience if so required by uploading the same at time of bid creation including approval of their competent authority. Service Providers's response may be assessed atime of technical evaluation.

Price Variation Clause:

"It is advisable to include Price Variation Clause in the long term contracts to take care of the increase/decrease in prices of various ingredients which majorly affect the overall price of the service. Buyers are therefore advised to include the Price Variation Clause (PVC) in the bid document through ATC for long term contracts. The additional payment, if any, on account of PVC can be done offline till such time online functionality is developed on GeM."
