## CSR ACTIVITIES UNDERTAKEN THROUGH CORPORATE OFFICE

### (A) HEALTH, NUTRITION & SANITATION:

- **Providing medical care and nutritional support to physically and mentally challenged persons residing at Cheshire Home India, Delhi Unit for the period of one year:**
- An MoU was signed with Cheshire Home India, Delhi Unit on 17.01.2024 for providing medical care and nutritional support to the physically and mentally challenged persons living in Cheshire Home India at Delhi unit. Under this initiative, a provision has been made to provide services of doctors, nurses, psychiatrists and attendants for day to day care of the physically and mentally challenged people. Around 60 residents of Cheshire Home are getting benefitted from this activity. The activity is under progress. Project cost is Rs. 68.24 Lakh. Under this activities, regular nutritional support is being provided as per the diet and individual needs of residents. Psychological /clinical and Physiotherapy session will be taken on regular basis.





➤ **CSR Support to School of Mentally Retarded Children in Sector-14, Faridabad by providing one time Capital Items and Running expenditure for three years (2023-24 to 2025-26).**

An MOU was signed with Rajasthan Association on 28.06.2023. NHPC has incurred Rs.18.38 Lakh in FY 2023-24 to meet running expenses and expenses related to capital items. Around 26 students are getting benefitted from this activity. The activity is under progress.



➤ **Afternoon Nourishment Meal Program for Underprivileged Girl Students at Amitasha Foundation for Upliftment of Under privileged Children at Noida, Uttar Pradesh.**

An MoU was signed between NHPC Limited and Amitasha Foundation on 06.10.2023. As part of this CSR initiative, Amitasha Foundation will be providing Afternoon Nourishment Meal for one year to 300 underprivileged girls students studying in their Noida center. This CSR initiative involves F.I. of Rs.9.90 Lakh and upto the end of FY 2023-24, an amount of Rs.4.41 Lakh was utilized.





➤ **Construction of 7 nos public toilets, named 'Sanitary Haven,' in various public places in Auraiya District, Uttar Pradesh:**

An MoU was signed between NHPC Limited and Uttar Pradesh Cooperative Processing and Cold Storage Federation Ltd (PASC FED), Auraiya on 26.02.2024 at NHPC Corporate Office. The scope of work includes the construction of a 7 nos of public toilet facility at various locations in District Auraiya, Uttar Pradesh. This CSR initiative involves F.I. of Rs.60.00 Lakh. Work is under progress.



➤ **Installation of 15 Nos Reverse Osmosis (RO) Water Treatment Plant 'Swachh Jal Dhara' at schools in District Gorakhpur of Uttar Pradesh:**

An MoU was signed between NHPC Limited and Society for Advancement of villagers Empowerment and Rehabilitation of All (SAVERA), New Delhi on 26.02.2024 at NHPC Corporate Office. The scope of work includes installation of 15 Reverse Osmosis (RO) Water Treatment Plants at schools in District Gorakhpur of Uttar Pradesh. This CSR initiative involves F.I. of Rs.74.93 Lakh. Work is under progress.



➤ **Installation of 10 Nos Reverse Osmosis (RO) Water System in District Basti of Uttar Pradesh:**

An MoU was signed between NHPC Limited and U.P. Small Industries Corporation Ltd, Ghaziabad on 20.02.2024 at NHPC Corporate Office. The Scope of work involves Design, Supply, Erection, Installation, Testing and Commissioning of Reverse Osmosis System (250 LPH) complete with fully automatic pre-treatment, chilling plant and post treatment for conditioning RO permeate to produce ideal quality treated water for domestic/ drinking and utility including chilling plant, water vending/ ATM machine with shed and floor complete. This CSR initiative involves F.I. of Rs.83.89 Lakh. Work is under progress.



➤ **Operation & Maintenance of Tank Type Stand Post (TTSP) Booths, Water lines & Tube wells for Chhoti and Badi Parikrama at Govardhan, Mathura for 3 years:**

An MoU has been signed with Uttar Pradesh Braj Tirth Vikas Parishad on 27.07.2023 and 1<sup>st</sup> Instalment of Rs.23.50 Lakh has been released and the activity is under progress. The no. of beneficiaries is more than 5 lakhs.





## (B) EDUCATION & SKILL DEVELOPMENT:

### ➤ Setting up of Kyan based Smart Classrooms for improved learning outcomes in 50 Govt. Schools of Uttarakhand.

An MoU was signed between NHPC Limited and Social Empowerment & Economic Development Society (SEEDS), New Delhi on 27.02.2024. The scope of work involves installation of Integrated Teaching Device (K-YAN), digital e-learning content with Multimedia content and English learning solution in 50 Government Schools of Champawat and Pithoragarh Districts of Uttarakhand. This CSR initiative involves F.I. of Rs.60.00 Lakh. Work is under progress.



### ➤ Hydro Engineering College, Bandla, Bilaspur: Managed by HP Government.

The classes are running in the Campus of Government Hydro Engineering College since 16 December, 2021. Physical work has been completed up to 94.5 % as per master plan, financial expenditure of 120.35 Crore has been incurred. Both NHPC and NTPC have provided CSR support for establishment of Hydro Engineering College. NHPC has contributed Rs. 62.50 Crore for this CSR initiative.





**(C) ENVIRONMENT:**

- **Empowering Rural Rajasthan: illuminating Pathways through Solar Street Lights in rural areas of Jodhpur and Jaisalmer Districts of Rajasthan.**

An MoU was signed between NHPC Limited and Arpan Seva Sansthan, Jaipur on 13.03.2024 at NHPC Corporate Office. The Scope involves procuring, installing, commissioning, and providing a 5-year warranty with maintenance for a solar street lighting system. It includes 150 Solar Street Lights and 3 Solar High Mast Lights distributed strategically across villages in Jodhpur (Aau and Shergarh) and Jaisalmer (Phalsund) Districts, Rajasthan. This CSR initiative involves F.I. of Rs.41.46 Lakh. Work is under progress.

### (D) ART & CULTURE:

- **Construction of Civic Amenity Building at Badrinath Dham through Shri Kedarnath Utthan Charitable trust (SKUCT).**

An MoU was signed with Shri Kedarnath Utthan Charitable Trust (SKUCT) on 18.10.2021 for the construction of a Civic Amenity Building in Badrinath Dham. Project cost is Rs. 18.58 crore. A total amount of Rs. 13.0 crore has been released in four installments. Slab casting of 1<sup>st</sup> floor has been completed & slab casting for 2<sup>nd</sup> floor & erection of roof truss is under progress. The activity has achieved 75% of targeted work. Under this activity, targeted beneficiaries are 1,25,000 nos.



### (E) RURAL DEVELOPMENT

- **Construction of 03 nos Community Halls in 3 villages of Krishna District, Andhra Pradesh:**

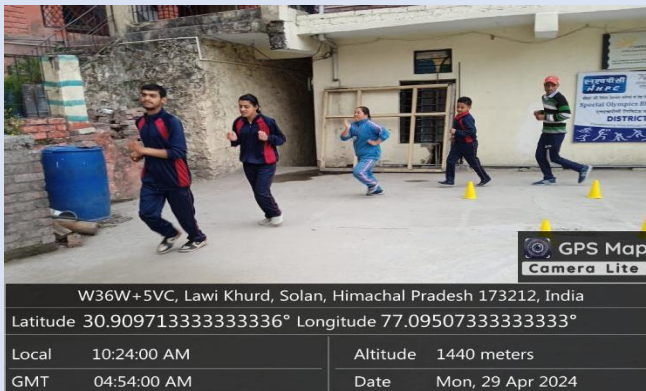
An amount of Rs. 143.00 Lakh was allocated for construction of 03 Community halls in 3 villages (Kalasamalapalli Village of Thotlavalluru Mandal, Angaluru Village, of Gudlavalleru Mandal and Tarakaturu Village of Guduru Mandal) in Krishna District, Andhra Pradesh. Work is under progress. No. of expected beneficiaries is 7843.





## E) TRAINING TO PROMOTE RURAL SPORTS/ PARALYMPIC SPORTS

- For providing Regular sports training to Persons with Intellectual and Development Disability (PWIDD), an amount of Rs.100.00 Lakh was allocated in FY 2023-24. An MoU had been signed on 19.07.2022 between NHPC and Special Olympics Bharat (SOB). Training is under process. No. of beneficiaries is more than 800.





# CSR ACTIVITIES UNDERTAKEN AT PROJECTS/ POWER STATIONS/ UNITS

## SALAL POWER STATION

- **Construction of community hall at Pounsali village (Total cost Rs. 60 lacs).**  
An amount of Rs. 30.00 lakh was allocated during the FY 2023-24. Approx. 70% work completed. The no. of beneficiaries will be approx.1300.



- **Saksham Livelihood and Skill Development Programmes for unemployed poor adolescent girls and women:**  
An amount of Rs. 3.80 lakh was allocated, out of which an amount of Rs. 2.0 lakh has been utilized. The activity is in progress. The no. of beneficiaries is about 50.



- **Improvement/ extension & providing of Water Supply to village Kotla and Theru (Ransoo) Distt. Reasi through gravity.**

MOU signed with PHED Reasi on 15.01.2020 for Rs.123.50 Lakh. Advance of Rs.81.5 lakh in 21-22 and Rs.42 Lakh in 2023-24 released. PHED Reasi has awarded the balance work on 09.11.2023 with a completion period of 90 days. Approximately 80% of the work has been completed by March 2024. PHED has submitted utilization of Rs.107.43 Lakh till date. The work to be completed shortly.





## NIMMO-BAZGO POWER STATION

### ➤ Furnishing of Library at Alchi Gonpa:

An amount of Rs. 22.37 lakh had been allocated in F.Y. 2023-24. Work is in progress. Approx. 50% work completed. About 300 persons will be benefitted from the activity.



## REGIONAL OFFICE, BANIKHET

### ➤ Vocational training courses of cutting & tailoring, Beauty culture and certificate in computer applications to rural youth through Yog Manav Vikas Trust, Banikhet, Distt. Chamba (HP) for three years 2023-24, 2024-25 & 2025-26 (Project Cost Rs.57.51 Lakh).

An amount of Rs.18.52 Lakh was allocated in FY 2023-24 and an MoU was signed on 27.07.2023 with Yog Manav Vikas Trust, Banikhet, Distt. Chamba (HP) for imparting vocational training courses. A total of 360 youths shall be provided vocational training courses. Training is in progress.





## SEWA-II POWER STATION

- **Construction of one female ward and one Tuberculosis ward at Sub District Hospital Bani:**

Work awarded on 02.12.2023. Approx 50 % work completed. Work is under progress. No. of beneficiaries is approx. 57000.



- **Improvement of Mela Ground at Mashka for creation of sports infrastructure for the promotion of culture of sports and engagement of local youths:**

An amount of Rs. 32.61 Lakh had been allocated in FY 2023-24. Work awarded on 08.12.2023 and completed on 11.03.2024. More than 1000 persons will be benefitted by the activity.



## BAIRASIUL POWER STATION

- **Construction of Balika Ashram, Chilli, Tissa**

An MoU had been signed with Govt of HP. Work awarded on 25-01-2023. An amount of Rs.300.00 Lakh has been allocated in FY 2023-24 and out of which an amount of Rs.289.06 Lakh has been utilized. Work is under process. Second floor column & slab casted. Second Floor Brick Work and Third floor Column work is in progress. The no. of beneficiaries is 50.





## PARBATI-II H.E.PROJECT

- **Installation of Grid Connected Roof Top Solar Plant in various Government Schools in District Kullu, Himachal Pradesh.**

NHPC Parbati-II Project (HP) signed an MOU on 12.10.2023 with M/s HIMURJA for installing 5 KW Grid Connected Roof Top Solar Plant in 13 Govt. Schools in Distt. Kullu (HP). This CSR initiative involves F.I. of Rs. 36.63 Lakh. MOU signed on 12-10-2023. Advance payment 70% released to M/S Him Urja. Work is under progress.No. of expected beneficiaries is 3692.



## TLDP-III & IV POWER STATION

- **Funding for construction of Engineering College, Takdah.**

Total estimated cost of the project is Rs.40.00 Crore and up to the end of FY 2023-24, an amount of Rs.26.00 Crore has been utilized. The work is under progress. The no. of beneficiaries is around 1000.





# TEESTA-V POWER STATION

## ➤ Construction of Mid-Day meal Kitchen at Govt. Sec School, Lower Samdong Gangtok, Sikkim:

An amount of Rs.9.00 lakh had been allocated in F.Y. 2023-24. Work awarded on 06.03.2024. Work is under progress. About 56 no. of persons will be benefitted by the activity.



## ➤ Construction of Boundary wall/ fencing at Lum School and Construction of Pathway in the Lum Village, North Sikkim:

An amount of Rs.12.00 lakh had been allocated in F.Y. 2023-24. Work awarded on 09.02.2024 and is under progress. More than 1000 persons will be benefitted by the activity.



## ➤ Provisioning of Sanitary Napkin Vending Machine and Incinerator in Government Secondary and Sr. Secondary Schools under 'Project Bahini':

MOU signed on dated 06.12.2022. 1st instalment of Rs.40.20 lacs & 2nd instalment of Rs. 20.10 lacs released. Total Rs 60,29,805 /- out of total amount Rs. 67 Lakhs has been utilized upto FY2023-24 and Installation is completed. Balance payment of Rs 6.70 lacs is under process. About 41645 persons will be benefitted by the activity.





➤ **Renovation, Beautification and providing infrastructure for the Saraswati Vidhya Niketan, Samdong (Sikkim):**

An amount of Rs.10.00 lakh had been allocated in F.Y. 2023-24. Work awarded on 19.03.2024. Work is under progress. The no. of beneficiaries is about 500.



## LIAISON OFFICE, LUCKNOW

➤ **Development of 5 nos of Parks by providing Solar Trees and LED Lights in the holy city of Ayodhya, Uttar Pradesh through CSR**

The above CSR initiative involves F.I. of Rs. 60.00 Lakh out of which Rs.12.00 Lakh has been utilized till date. Work is under progress. No. of expected beneficiaries is 45000. This CSR initiative is being implemented through UPNEDA (Uttar Pradesh New & Renewable Energy Development Agency) in Geographical area of Municipal Corporation, Ayodhya.



➤ **Construction of Community/ Marriage Halls at Village Mawaiya and Village Rehnas of Block Sarsaul of District Kanpur:**

MOU was signed on 26.07.2022 with PWD, Kanpur for Rs. 81.52 Lakh and out of which Rs.57.06 Lakh has been utilized till date. Work at Rehnas and Mawaiya village in progress. Approx. 6325 persons will be benefitted by the activity.

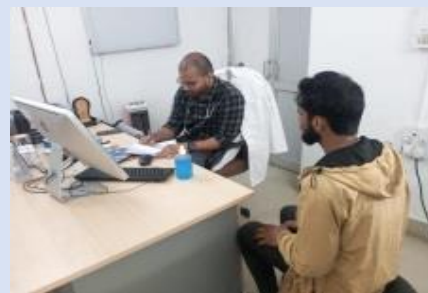
