Kindly refer to your letter as mentioned above vide which budgetary for laboratory investigations for the proposed Subansiri Upper HE Project, Arunachal Pradesh has been submitted. In this connection NHPC Limited, Subansiri Upper HE Project is pleased to place letter of award for the above work for an amount of Rs.12,03,900.00 (Rupees Twelve lakh Three Thousand Nine Hundred only) inclusive of GST@18% as per ANNEXURE-A but excluding transportation charges (in the scope of NHPC Limited). It is submitted here that as per NHPC's requirement work will be executed with certain terms and conditions. Acceptance by CSMRS of the following terms and conditions as given under for execution of above works is required:

#### 1. Scope of work:

- Evaluation of aggregates (Rock Quarries) for Alkali Carbonate reaction shall be carried out for 01 Shaol deposit sample & 07 rock quarry samples. The study shall be done as per ASTM C 1105, analysis and interpretation of test results, preparation of testing and evaluation report covering suitability of the aggregates.
- b. Evacuation of rock Quarry material for potential Alkali-Aggregate reactivity shall be carried out for 03 rock quarry samples. The study shall include Petrographic and Mineralogy analysis of 03 rock quarry samples as per IS:2386 Part VIII. Mineralogical details shall be analyzed covering the absence/ presence of reactive aggregates prone to Alkali-Silica reaction, to carry out accelerated mortar bar test on 03 rock quarry samples as per ASTM C 1260, analysis and interpretation of test results, preparation of testing and evaluation report covering suitability of the aggregates.
- 2. Completion time: As per the guidelines provided in ASTM C 1260.
- 3. Standard Guidelines: The study must confirm to the existing standard guidelines read with order/ circulars/policies of Centre/ State Govt. governing such study/plan issued from time to time.
