

Unit#1 got tripped due to Generator differential protection and Overall differential protection operated. Further huge amount of fire and smoke is observed in Unit#1 Generator. As per inspection done after the incident occurred on unit #1, it was found that Phase to Phase fault is occurred between Top bar of slot no. 122 and Bottom bar of Slot no.123 stator bars and impact of arc produced affected the components of stator from Slot no. 120 to 216 and Slot no. 1 to 33. Further for checking healthiness of the core, ELCID test was conducted through CPRI after completion of work and also during Annual Maintenance of the Generating Unit. Considering the healthiness of stator core and in order to avoid any further damage, it is necessary to conduct timely inspection of stator core. Further in order to inspect the non-visible faults, it is also necessary to conduct ELCID test on stator core. The electromagnetic core imperfection test (ELCID) is performed to detect stator core interlamination imperfections that can eventually cause overheating and damage to the stator core generator when in operation. Further, inspection of stator and ELCID test on core is possible only during the annual maintenance period as it requires removal of rotor pole which is preferably during annual Maintenance period.	26-Dec-24	Not applicable
