- 5.0 You are requested to submit the performance security of 2% (Two percent) of the contract price which comes to **Rs.2,27,121.00** (i.e., $2\% \times 1,13,56,052.00 = \text{Rs.}2,27,121.00$ only) valid till 90 days beyond the end of defect Liability period and additional performance security of 10% of accepted contract price which comes to **Rs. 11,35,605.00** only for higher rated items & low rated items valid till the time of completion of works for due performance of contract within 28 days after receipt of issue of this Letter of Acceptance in terms of Clause-3 of Conditions of Contract.
