Consequently, the connectivity between Power House and Administrative Office has been cut off and the approach road to the Bridge at Right Bank has also been washed out. Since the quantum of damages occurred to Infrastructure at Balutar is quite significant, a resourceful contractor was required for restoration of the same to minimize the restoration time to the extent possible. Accordingly, M/s Jaiprakash Associates Ltd. (JAL), a resourceful Major Contractor, already engaged for carrying out construction activities associated with Major Package of Teesta-VI HE Project was directed for early execution of Suspension bridge of Teesta-V infrastructures, 2023 to connect both left and right bank of Balutar Complex etc. This is rare and exceptional circumstances covered under natural calamities.
