Further, a request was received from the Water Resources Department (WRD), Government of Sikkim, proposing execution of the works through their department, along with a fund transfer proposal. Considering local sensitivities, for effective coordination with the local administration, for timely completion, WRD's role as a key regional stakeholder, it was considered appropriate to award the work to WRD on a deposit basis.

Email id: wrdgov23@gmail.com	Deposit/Work Order	The work was initially awarded through open tender, however, commencement of site activities was obstructed due to resistance from local inhabitants in the site of execution. In view of the prevailing law and order concerns, the District Collector, Gangtok, vide Memo No. 391/DCG/2025 dated 16.06.2025, advised termination of the contract. Subsequently, the Water Resources Department (WRD), Govt of Sikkim, requesting that the said work be executed through their department. Considering the local sensitivities and the need for effective coordination with the District Administration, it was proposed to foreclose the existing contract and reassign the work to WRD, Govt of Sikkim.

Some ACs are not working properly and need refilling of Gas and repair/servicing. Hence, immediate cleaning, servicing and repairing of these air conditioners was required due to harsh hot and humid weather conditions during monsoon season. Also, repairing of ACs is specialized job and no one in Regular & Contractual manpower of electrical maintenance division is trained for such jobs. Hence a WO was placed for repair and servicing of faulty ACs in Power Station.
