In reference to our earlier letter dated 03.10.2025 on above cited subject, it is to inform that name of RTA and date of appointment in respect of AF Series Bonds and AG Series Bonds for the quarter ended 30.09.2025 was inadvertently reported as 'Beacon Trusteeship Limited - 16.04.2025 (AF Series) and 12.08.2025 (AG Series)' instead of 'RCMC Share Registry Pvt. Ltd. - 19.04.2025 (AF Series) and 18.07.2025 (AG Series)' respectively. Accordingly, the revised report under Regulation 7(1) of SEBI (LODR) Regulations, 2015 for the quarter ended 30.09.2025 is attached.

The same mistake had occurred for the quarter ended 30.06.2025 also where name of RTA and date of appointment in respect of AF Series Bonds was inadvertently reported as 'Beacon Trusteeship Limited - 16.04.2025' instead of 'RCMC Share Registry Pvt. Ltd. - 19.04.2025'. The same may be taken note of.
