कृपया उक्त संदर्भित कार्यालय आदेश तथा परिपत्रों का संदर्भ ग्रहण करें जिनके माध्यम से उक्त विषयक वेतन विसंगति दूर करने हेतु दिशानिर्देश समय-समय पर जारी किए गए हैं। उक्त के संबंध में इस कार्यालय को पर्व कार्मिकों तथा उनके आश्रितों/ परिवारजनों के दावे प्राप्त हुए हैं। प्राप्त दावों में से कुछ मामलों में विसंगति/ कमी होने के कारण मामलों के निपटान में काफी दिक्कतें आ रही हैं जिनके दृष्टिगत दिशानिर्देश निम्नवत प्रस्तृत हैं:-
