<b>Sl. No.</b>	<b>Conditions stipulated in EC letter of Chamera-II Power Station (EC letter dated 06.03.1985)</b>	<b>Status of Compliance (as on Sept, 2025)</b>
i	A necessary fuel arrangement should be made to the construction workers, at project cost, to prevent indiscriminate felling of trees in the neighboring forest areas. For this fuel depots should be opened in project area and suitable provision should be made to cover this cost.	Chamera-II Project has already been commissioned in 2004. As such, there is no requirement of free fuel arrangement on account of construction workers. However, for project staff, LPG cylinders are being arranged from LPG depot located at Karian, Chamba.
ii	Restoration of construction area should be ensured to the extent possible by : -Levelling and filling of borrow pits, -vegetation of exposed slopes and -landscaping etc.	Chamera-II Project was commissioned in 2004. The restoration of construction area was undertaken by way of filling of borrow pits, levelling and slope protection measures alongwith landscaping and plantation. Repair and maintenance work of dumping sites have been undertaken by NHPC in the month of Jan., 2023 with an expenditure of Rs. 28.19 lakhs.
iii	Afforestation should be undertaken on large scale in the project area, along the reservoir periphery and the water conductor system by creating the green belt. Adequate provision for this, therefore, be made in project estimate.	Green Belt Plan was implemented through State Forest Deptt. at a total cost of Rs 55.20 lakhs.
iv	Anti-poaching law should be strongly enforced around the project areas to provide protection to forest cover around and wild life. If required, necessary additional staff should also be provided to reinforce the control mechanism.	Enforcement of the anti-poaching law is being done by the HP State Forest Deptt.
v	A monitoring committee should be constituted with representative from state Forest Deptt., wildlife wing and Govt. Deptt. to oversee the effective implementation of the suggested safeguards and to minimize the damage to the surrounding environment.	Environment monitoring committee has been constituted by Project vide circular No NH/CH-II/C&P/P-165/2000/208-13 dated 16.02.2000.
