शिवसेना के रुख से सरकार की स्थिरता पर उठे सवाल

बल्कि इन पर धरेलु कर परिवर्जन नियमों के जरिये नजर रखने की भी आवश्यकता है। सीबीडीटी ने कहा कि गार लागू करने के प्रस्ताव को पहले आयकर के प्रधान आयुक्त के स्तर पर परखा जाएगा और उसके बाद हाई कोर्ट के न्यायाधीश की अध्यक्षता में गठित मंजूरी समिति के स्तर पर इसे देखा जाएगा।

सीबीडीटी ने कर नियमों में स्पष्टता, विश्वसनीयता के लिए सरकार की प्रतिबद्धता का वादा करते हुए, 'सभी संबंधित पक्षों को आश्वस्त किया है कि इसके लिए सभी उपयुक्त उपाय किए गए हैं कि गार को समान, उचित और तर्कसंगत तरीके से लागू किया जाए।' कर विभाग ने यह भी स्पष्ट किया है कि गार के तहत कोई भी जुर्माना यदि लगाया जाता है तो वह मामले के तथ्यों और परिस्थितियों को ध्यान में रखते हुए होगा। ऑटोमेटिक प्रक्रिया के तहत यह नहीं होगा।

महाराष्ट्र में महानगरपालिका और अन्य निकाय चुनाव अपने दम पर लड़ने के शिवसेना के फैसले के बाद निगाहें राज्य में भाजपा की अगुवाई वाली सरकार की स्थिरता पर टिक गयी हैं क्योंकि उद्धव ठाकरे की भी सरकार में सहयोगी है।

भाजपा के साथ सीटों के बंटवारे को लेकर वार्ता के विफल रहने के कारण ठाकरे द्वारा अपनी पार्टी का रुख साफ करने के एक दिन बाद शिवसेना के वरिष्ठ नेता और राज्य सरकार में मंत्री रामदास कदम ने आज कहा कि उन्होंने और उनके साथियों ने अपना त्यागपत्र अपना जेब में रखा हुआ है और वे पार्टी प्रमुख के इशारे की प्रतीक्षा कर रहे हैं।

भाजपा के हलके ने हालांकि इस तरह के बयान को ज्यादा अहमियत नहीं दी और कहा कि सहयोगी दल के निर्णय से देवेंद्र फडणवीस सरकार की स्थिरता पर कोई फर्क नहीं पड़ेगा। वहीं इन राजनीतिक घटनाक्रमों पर राकांपा की करीबी निगाह बनी हुई है।

हालांकि पार्टी सुप्रीमो शरद पवार ने स्पष्ट तौर पर यह बताने से इनकार कर दिया कि सरकार से शिवसेना के हटने के बाद उनकी पार्टी का रुख क्या होगा। उल्लेखनीय है कि 2014 के विधानसभा चुनाव में भाजपा को स्पष्ट बहुमत नहीं मिलने पर राकांपा ने भाजपा को बाहर से समर्थन देने का ऐलान किया था।
