#### **Impact on Construction Projects:**

#### 1. Parbati-II HE Project:

The construction activities of the project were completed halted from 23.03.2020 to 22.04.2020 due to lockdown announced by Central Govt./State Govt. to contain spread of CoVID-19 pandemic. The construction works of the Project has been affected due to various movement restrictions imposed in the wake of CoVID-19. The effect of shortage of labour may affect construction schedule and enhance completion cost of the Project.

### 2. Subansiri Lower HE Project:

All construction works of Subansiri Lower HE Project was suspended w.e.f. 24.03.2020 in view of lockdown announced by Central Govt./State Govt. to contain spread of CoVID-19 pandemic. As per Ministry of Home Affairs (MHA), Govt. of India order dated 15.04.2020, District Administration allowed resumption of work w.e.f. 20.04.2020 for urgent activities by deployment of minimal labour adhering to CoVID-19 guidelines. Due to lockdown, completion time of the Project has been affected. The lockdown would also have impact on costing of the Project.

#### **Impact on Power Stations:**

The restoration schedule of three Power Stations i.e. Chamera-II Power Station, Kishanganga Power Station, Loktak Power Station has been affected due to movement restrictions imposed in wake of CoVID-19 pandemic. An estimated loss of Rs. 119.43 crore is expected due to anticipated generation loss.
