Shri Ratish Kumar (55 years) is B.Tech in Electrical Engineering from GB Pant University of Agriculture & Technology, Pantnagar (U.P). Shri Ratish Kumar started his professional career in NHPC Limited as Trainee Engineer in October 1982 from Baira Siul Project.

Shri Ratish Kumar has over 33 years of experience in NHPC where he climbed up the professional ladder with utmost sense of responsibility, ethics and dedication. His major contributions in hydro-power sector has been in the field of Electro-Mechanical Design, Construction, Erection, Operation & Maintenance of Hydro Power Stations. He has also worked in different capacities in NHPC at Design (E&M) Division, Baira Siul, Salal and Parbati projects.
