'Law won't go by mental age'

SC: Pocco Act To Consider Biological Age Of Survivor

Pocco was brought into force in 2012 with an intent to protect minor victims and avoid re-victimisation of the child at the hands of the judicial system

New Delhi: The Supreme Court on Friday ruled that it is the biological and not mental age of a rape survivor which should be the yardstick for deciding whether the case would be filed under the stringent Protection of Children from Sexual Offences (Pocco) Act.

A bench of Justices Dipak Misra and R F Nariman said taking into account the mental age of a rape survivor to invoke Pocco would encroach upon legislative function. "...to include the perception of mental competence of a victim or mental retardation as a factor will really tantamount to causing violence to the legislation by incorporating certain words to the definition. By saying age would cover mental age has the potential to

create immense anomalous situations without there being any guidelines or statutory provisions. Needless to say, they are within the sphere of legislature," Justice Misra said in the lead judgment.

"If a victim is mentally retarded, definitely the court trying the case shall take into consideration whether there is a consent or not. In certain circumstances, it would depend upon the degree of retardation or degree of understanding. It should never be put in a straightjacket formula. It is difficult to say in absolute terms," he said.

10-year-old rape survivor moves SC for abortion

A 10-year-old rape survivor, who was denied permission by Chandigarh district court to abort her 26-week-old foetus, has approached the Supreme Court to get its permission to terminate her pregnancy. Appearing before a bench, her advocate sought an urgent hearing on her plea to abort the foetus. Agreeing to hear her plea, the court posted the case to July 24. **TNN**

All parties say will wait for 9-judge ruling on privacy

Though the case saw some rapid fire exchanges, all concerned, including the bench and all sides in the dispute, agreed that the issue of privacy will need to be addressed and it might be best to wait till it is settled by the nine-judge bench hearing the challenge to Aadhar on the grounds that privacy is a fundamental right. The government, in the Aadhar case, is arguing that reasonable restrictions can be imposed on individual's privacy.

Salve accused WhatsApp of taking advantage of its near monopoly in the free messaging platform to force users to believe that if they did not agree with the privacy policy, they would not be able to enjoy the service. "It may be WhatsApp today and Uber tomorrow or any other ticketing services run by non-state players. The question is — can they use my personal data for commercial exploitation? Is this not violation of privacy?"

Sibal said millions of users have no problem about the WhatsApp privacy policy. "Why only two petitioners have problems with WhatsApp when similar data-sharing is going on in all platforms? There is a design in targeting WhatsApp. If any injury is caused to any user because of data-sharing, WhatsApp will be liable. But the government cannot regulate on mere possibility," he said.

The bench said: "Why cannot the court say because you (WhatsApp) are providing a public service, you cannot impose conditions on users and tell them that they can access the service only if they accepted the privacy policy? Are you not curtailing free choice?"

SC asks CBI to file chargesheet in all Vyapam cases by Oct 31

New Delhi: The Supreme Court on Friday set October 31 as deadline for CBI to file chargesheet in all pending Vyapam scam cases and ordered it to submit the forensic test report of the seized hard disk and pen drive before the trial court along with the chargesheet.

In response to a petition by 'whistle-blower' Prashant Pandey, the CBI had said: "The present petitioner, in his petition, alleges tampering of one of the computer hard disks seized by police in 2013". Congress leader Digvijaya Singh had filed a writ petition before the SC making similar allegations. **TNN**

RBI rejected ₹22cr in old notes: Coop bank

New Delhi: A Pune cooperative bank on Friday complained to the Supreme Court that RBI was not accepting scrapped currency notes of Rs 500 and Rs 1000 amounting to Rs 21.96 crore lying with it as deposits accepted before November 9, when the demonetisation came into effect.

At a time when ten petitioners are awaiting a fresh window for exchange of scrapped currency notes, senior advocate P Chidambaram told a bench of Chief Justice J S Khehar and Justice D Y Chandrachud that the cooperative bank has been writing to RBI and NABARD, but there

has been no response so far.

Appearing for Pune District Central Cooperative Bank Ltd, Chidambaram said that at the beginning of the demonetisation exercise, the cooperative banks were permitted to accept

deposits in scrapped currency notes but it was discontinued a week later. "These banks have accepted deposits worth over Rs 100 crore and are not being able to exchange it... There was no logic in not accepting scrapped notes which documents establish were accepted before demonetisation," he said. The bench sought RBI's response in two weeks.

KLM also serves veg to economy flyers

New Delhi: Air India may have been roasted on social media for recently going all-vegetarian in economy class of its domestic flights, but it now emerges the Maharaja is not the only one doing so. Royal Dutch Airlines KLM serves veg meals to economy class passengers on its India-Amsterdam flights. Unlike AI's short domestic flights that can at most be three hours long, the flying time between Delhi and Amsterdam is almost eight hours.

Nandini Guha, an associate professor at Delhi University, discovered this fact to her surprise while visiting Europe last winter. "I flew Delhi-Amsterdam-Copenhagen on the way out and flew back from Helsinki via Amsterdam. I

was travelling economy class and KLM did not serve non-veg meals on its flights to and from Delhi. We were given the option of choosing either Italian veg or Indian veg. Even alcohol was not served and we were given only juice," Guha, who is in DU's department of English, said.

Confirming its veg-only policy for budget flyers, a statement by KLM said: "On flights from Delhi to Amsterdam, as part of first service, we serve vegetarian meal in economy class." KLM currently has a daily flight on Delhi-Amsterdam route.

Niti nod to raise train speed in 2 corridors

New Delhi: Two key projects of railways costing around Rs 18,163 crore to raise the speed of trains to 160-200 kmph on two busy corridors — Delhi to Mumbai and Delhi to Howrah has got clearance from Niti Aayog.

Railways minister Suresh Prabhu informed Rajya Sabha that the Delhi-Mumbai route (1,483 km) will cost around Rs 11,189 crore, while Delhi-Howrah route (1,525 km) has an estimated cost of Rs 6,974 crore. Prabhu said the two projects on existing corridors of New Delhi-Mumbai (including Vadodara- Ahmedabad) and New Delhi-Howrah (including Kanpur-Lucknow) have been processed for sanction.

During Question Hour, Prabhu said, "The main outcome of the implementation of these projects is increase in the maximum speed of train on these routes to 160 km per hour. This will reduce the travel time of premium Rajdhani-type trains to 12 hours as against the present travel time of 15 hours 30 minutes and 17 hours respectively for Mumbai and Howrah Rajdhani."

350 rly officials facing penalty

Over 350 railway officers are facing cases of major penalty, the government informed the Rajya Sabha on Friday. Minister of state for railways Rajen Gohain said 251 Group A and 128 Group B officers were facing DAR (Discipline and Appeal Rules) cases. **TNN**
