1. 5. Failure to submit the prescribed **Online Consent** within the stipulated period and/or non-appearance in the Personal Interview, Group Discussion and Psychometric Assessment shall result in cancellation of candidature under Recruitment Notification No. NH/Rectt/02/2026, in accordance with Clause (D) under the heading "Selection Process" of the said notification.
6. Interview Call Letters for the Personal Interview, Group Discussion and Psychometric Assessment shall be issued only to those candidates who submit their Online Consent within the prescribed timeline.
7. If at any stage of the recruitment process, including after appointment or joining, it is found that any information furnished by a candidate is false, incorrect, incomplete, misleading, or not in conformity with the eligibility criteria prescribed in the recruitment notification, or if any material fact has been concealed, the candidature/appointment shall be liable to be cancelled forthwith without assigning any reason.
8. Shortlisting of candidates has been carried out on the basis of the **best normalized GATE score obtained in GATE-2024 or GATE-2025**, as applicable.
9. In cases where two or more candidates have secured the same cut-off score, all such candidates have been shortlisted and called for the further selection process.
10. The list of original documents required for verification at the time of Personal Interview, Group Discussion and Psychometric Assessment shall be specified in the Interview Call Letter.

Candidates presently employed in Government Departments, Public Sector Undertakings (PSUs), Autonomous Bodies, or similar organizations are required to produce a valid **No Objection Certificate (NOC)** from their employer at the time of document verification. Failure to produce the NOC in original shall result in cancellation of candidature, and such candidates shall not be permitted to participate in the further selection process.
