E.O.I. FOR EMPANELMENT OF ARBITRATOR

1. NHPC Limited, a Govt. of India Enterprise, is the largest hydropower development organization in India, with capabilities to undertake all the activities from conceptualization to commissioning of hydro projects. NHPC has also diversified in the field of Solar, Wind and Green Hydrogen energy development. NHPC is a listed company on NSE and BSE.
2. NHPC is a Navratna Enterprise of the Govt. of India and has executed 31 projects with an installed capacity of 9332.90 MW including 1681.7 MW in Joint Venture, comprising 8771.2 MW from 24 Hydro Power Stations, 511.70 MW from Six (06) Solar Power Project and 50 MW from a Wind Power Project. NHPC including its JVs/ Subsidiaries is presently engaged in the construction of 17 projects aggregating to a total installed capacity of 9204 MW.
3. During the course of execution of Projects, at times disputes arise with Contractors. The Contract contains provision for arbitration as a measure of dispute resolution between the parties. NHPC maintains a panel of Arbitrators for the purpose of appointing its nominee Arbitrator for constitution of Arbitral Tribunal for adjudication of unresolved disputes that may occur in ongoing / completed Projects.
4. Accordingly, "Expression of Interest (EOI)" is invited from persons having requisite qualification, for empanelment as an Arbitrator wherefrom the NHPC nominee arbitrators could be appointed for adjudication of cases involving disputes of value above ₹ 75 Lakhs.

5. ESSENTIAL REQUIREMENTS

Dignitaries interested to act as Arbitrator and fulfilling the following minimum criteria may apply for the nomination in the panel of arbitrators within **10 days** from the date of issue of this EOI

i) Eligibility Criteria

- Retired Judge of the Supreme Court or High Court.

- Retired Central Civil Service officer holding scale of either Secretary in Central Government or Chief Secretary in the State Government Or equivalent.
 - Retired Officer of Technical/Finance/Law cadre of the level of Executive Director and above Or equivalent of Schedule "A" organizations/PSUs having experience in handling contracts or dispute resolution mechanism relating to Hydro Power/Infrastructure Projects.
[Pay Scale of E-9 level of NHPC: Rs. 1,50,000/- - Rs. 3,00,000/- Revised as on 01.01.2017(Pre revised pay scale Rs.62,000/- - Rs.80,000/-)]
 - Retired Officer of Technical/Finance/Law cadre of the level of Engineer-in-Chief and above of Central/State Government Department Or equivalent having experience in handling contract or dispute relating to Hydro Power/Infrastructure Project.
- ii) Age as on date of application should not exceed 70 years.
 - iii) A person shall remain on the Panel of Arbitrators for a period of maximum 03 Years and thereafter the name of the person shall stand automatically deleted from the panel of Arbitrators. However, he/she will continue to conduct the ongoing Arbitration, if any.
 - iv) The person appointed as a nominee arbitrator by the Contractor in the matter of any dispute with NHPC shall not be eligible for empanelment.
 - v) The applicant shall also undertake not to take assignment (against NHPC) from any of the NHPC and its JVs/Subsidiaries Contractor during the period of empanelment with NHPC.
 - vi) Mode of receiving applications for the empanelment will only be through this 'Expression of Interest' published on **website of NHPC or CPP Portal**. The applications received shall be considered on first come first serve basis.
 - vii) The empanelment through this EOI shall not exceed more than **10 in numbers**.

Further, before applying, the applicant has to ensure that he/she is eligible in terms of Fifth and Seventh schedule to Arbitration and Conciliation Act, 1996 (as amended in 2019). Persons who have retired/resigned from the service of NHPC or its subsidiary/ JV, i.e., NHDC, CVPP etc. shall be considered for empanelment only after the expiry of **03 Years** from the date of their retirement/resignation.
