**Re: Rating Letter for NHPC Limited**

India Ratings & Research (Ind-Ra) has assigned NHPC Limited's proposed INR16bn (including a green shoe option of INR14bn) secured non-convertible taxable bonds a long-term 'IND AAA(exp)' rating subject to receipt of final documents in confirmation with documents already received.

The outstanding ratings including the above are as follows

- Long-Term Issuer Rating : IND 'AAA' / 'Stable' Outlook
- INR20bn long-term bond programme : IND 'AAA'
- INR20bn long-term loan programme : IND 'AAA'
- INR15bn long-term bond programme : IND 'AAA'
- INR15bn long-term loan programme : IND 'AAA'
- INR10bn non-convertible tax free bonds : IND 'AAA'
- INR1.55bn working capital loans : 'IND AAA' / 'IND A1+'
- Proposed INR16bn non-convertible bond programme : IND AAA(exp)

**The terms and conditions of the proposed bonds are provided in the Annexure.**

India Ratings notes that the ratings are assigned to the programme and not to the notes issued under the programme.
