Sub: **Engagement of Industrial Trainees (Article Trainee) under the Provisions of The Institute of Chartered Accountants of India/The Institute of Cost Accountants of India – regarding.**

NHPC Limited is India's premier hydropower utility with ability to construct hydro projects from concept to commissioning with a 'Navratna' status. We being registered by The Institute of Chartered Accountants of India/The Institute of Cost Accountants of India, intend to enroll approximately 20 (Twenty) students for article-ship for the said training.

PRESCRIBED CRITERIA FOR ENROLLMENT

The Article Trainee must have passed Intermediate examination conducted by Institute of Chartered Accountants of India/The Institute of Cost Accountants of India. The Industrial training shall be for a minimum period of 12 months and maximum of 15 months during the last year of the prescribed period of practical training.

TERMS & CONDITIONS OF ENROLLMENT

1. The candidates will be selected for the enrollment through an interview, the date for which shall be informed separately.
2. The candidate shall have to enter into an agreement of training in the form as approved by the Organization.
3. The selected candidates while on training shall be paid a consolidated stipend of **Rs. 20,000/-** (Rupees Twenty Thousand only). They will not be entitled to any other financial benefit over and above the consolidated monthly stipend.
4. The trainees will be entitled to leave as admissible under the extant rules of company for Industrial Trainees. In addition, trainee will also be entitled for leave in excess of the above to maximum period of 2 months without stipend for the purpose of attending examinations.
5. On satisfactory completion of the industrial training, the trainees will be issued a certificate by the organization in respect of the training undergone.
6. The trainees on completion of their training under the above arrangement shall not have any right for employment in NHPC being a part of course curriculum.

7. The place of Training will be at NHPC Corporate Office, Faridabad, so candidates from local area will be preferred. Selected candidate have to make their own arrangement for stay. No accommodation shall be provided by NHPC.
