1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. - v. **Test Reports:** The bidders are requested to furnish the latest certificate (Test Report) of following tests conducted at any independent recognized institute on ADSS OFC cable offered by them:

- Tensile strength test of ADSS Optical Fibre Cable, in order to examine the behaviour of the attenuation as a function of the load on a cable.
- Crush/ impact test to determine the ability of an optical fibre cable to withstand crushing and impact.
- Cable bend test to determine the ability of an optical fibre cable to withstand repeated flexing.
- Cable bend Test at High & Low Temp to determine the ability of an optical fibre cable to withstand bending at low and high temperatures, which might be encountered during cable placement.
- Water Penetration/Blocking Test to ensure that installed optical fibre cable will not allow water passage in the cable.

- vi. **Scope of Contract:** The scope of this contract shall be as per technical specifications attached in the bid.

- vii. **Terms of Payment:**

- FOR SUPPLY PORTION: 100% payment shall be released against the submission of dispatch documents and successful delivery of the material at site

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्यवाई का आधार होगा।
