#### 2.0 Eligibility Criteria for Bidders:

- 2.1.1 Deleted
- 2.1.2 This Invitation for Bid is open to:
  - a) The bidders who are incorporated legal entity and are legally and financially autonomous and operate under commercial law of their respective jurisdiction.
  - b) Shortlisted bidders (as per approved list) found suitable for this work whose Login IDs have been configured by the Employer at CPP portal.
- The bidders must fulfill the following minimum Qualifying Criteria:-2.2
- 2.2.1 The prospective bidder shall fulfill the following minimum eligibility criteria, supported with relevant documentary proofs:
  - a) The bidder should produce notarized valid DGR Empanelment Certificate (with photograph and signature of Proprietor/ Directors)
  - b) The bidder should produce a copy of sponsorship letter issued by DGR in favour of bidder.
  - c) The bidder should produce PSARA certificate for operating as private security agency in the state of Arunachal Pradesh.

- 2.2.4 The reference date for considering the period for eligibility / qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.
- 2.2.5 Each bidder must also produce with their Bid PAN, Goods & Services Tax Identification No. (GSTIN), EPF Registration No. and ESIC Registration No.
- The Bidder should not have been banned / de-listed / black listed / debarred from business or declared ineligible on the grounds mentioned in para 6 of Guidelines on Banning of Business Dealings (Annexure-A) to Integrity Pact [if applicable], ITB Clause 9.0. Self-declaration in this regard is to be submitted as per enclosed Annexure-III.
- To improve transparency and fairness in tendering process and/or during execution of work undertaken, the Employer is implementing Integrity Pact as per Clause No. 9.0 of the ITB. The bidder must submit the Integrity Pact as per Proforma (Annexure-II) duly signed as per Clause 9.0 of ITB.

Pre-contract Integrity Pact is to be executed on plain paper with NHPC Ltd. at the time of submission of Bids. The successful bidder (Contractor) shall submit duly executed Integrity Pact on Non-Judicial Stamp Paper of appropriate value prior to signing of Contract Agreement.

To oversee the compliance of obligation under the Integrity Pact Dr. Vinod Aggrawal, IAS (Retd.) & Shri Prabhash Singh, ITS (Retd.) have been appointed as Independent External Monitor (IEM) by the Purchaser/ Employer. - 2.5 The Bidder, against whom proceedings for insolvency under the Insolvency and Bankruptcy code 2016, or as amended from time to time, have started, shall not be eligible for bidding. Self-declaration in this regard is to be submitted as per enclosed Proforma (Annexure-X of Section-I).
- 2.6 All bidders who are Class-I Local Supplier under Public Procurement (Preference to Make in India) order for Goods/ Services/ Works issued by Department of Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry Order No. P-45021/2/2017-PP (BE-II) dated 16th September, 2020 or as amended are only eligible. Further, Local content / Class-I local supplier etc. defined in ITB clause 15, in this regard bidders must submit undertaking as per as per Annexure-XIII, Section-I.
- 2.7 In terms of Rule 144 (xi) regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in tender, Bidder has to undertake compliance of this as per Annexure-XIV, Section-I and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws. The provision under Rule 144 (xi) of GFR are indicated in ITB clause 16.
- 2.8 Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the Contract. Bidders will submit duly notarized requisite supporting documents and testimonials with their Bids to prove their credentials and claim of meeting the Eligibility Criteria.
- 3. The details/ information regarding online tendering i.e. Registration on CPP portal, Preparation of Bid and Submission of bid are available in the tender document and as well as on CPP Portal under "Bidders Manual Kit".
- 4. NHPC reserves the right to reject any or all tenders and shall not be bound to assign any reason for such rejection.
