In light of above, we would appreciate your confirmation of the following:

• Erection and Commissioning Scope: Should the erection and Commissioning activities be considered only for the new Gates (Sl. No. 1), or do they apply equally to the refurbishment and repair of damaged gates (Sl. No. 3)?

Additionally, it is important to note the following:

• Uncertainty regarding the extent of refurbishment: At the time of quoting, the specific condition and quantity of the refurbishment work could not be determined due to the unknown extent of damage to the gates. The extent of repairs and refurbishment required will only become

apparent once the gates are inspected after rescued from the debris.
• Structural Considerations: Based on our
expertize, while the TRT gates may require structural; refurbishment, the primary
challenge lies in the repair of the end-
carriage and associated wheel assemblies.
These components are highly precise and
must be installed with a high degree of
accuracy. Such precision is difficult to
achieve at the site, and it is possible that the
gates ,ay need to be returned to the workshop
of proper repairs
• Cost Implications: If the refurbishment
work requires the procurement of new wheel
assemblies and the manufacturing of new
end-carriages with precision-machined holes,
this will incur significant costs. The precise
installation of these components must be

BOQ value for Sl. No. 3	
(Refurbishment/Repair of Damaged TRT	
Gates) not be factored into the tender evaluation	
at this stage, as the scope of work and associated	
cost cannot be accurately determined without a	
detailed assessment of the actual damage and	
required repairs.
