2.0 Eligibility Criteria for Bidders:

2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD (as per Instructions to Bidders (ITB) Clause 3.0 & 4.0) shall not be considered for evaluation, except in case of exemption as per Clause No.3.2 & Clause No. 4.1 of ITB.

Further, those Bidders who fail to declare Udyog Aadhaar Memorandum (UAM) number on Centre Public Procurement Portal(CPPP) shall not be able to avail the benefits available to MSEs as contained in Public Procurement Policy for MSEs Order, 2012 issued by Ministry of Micro, Small & Medium Enterprises for tender invited electronically through CPPP. Such bidders shall be treated as non-MSE bidders and bids of such Bidders shall be considered only if it is accompanied by Cost of bidding document (Tender Fee/EMD (Bid Security).

Above declaration on CPP Portal can be done using following steps:

- 2.2 The bidders must fulfil the following minimum Qualifying Criteria:-
- 2.2.1 The tender is open for all bidders but first preference will be given to eligible PAFs of Dibang MPP in order of their quoted price(from lower to higher) subject to matching of L1 price. In case of inability/ineligibility of PAFs for all tendered quantities then next preference for balance quantities to local residing in lower Dibang valley district & Dibang valley district of Arunachal Pradesh in order of their quoted price (from lower to higher) subject to matching of L1 price and so on to technically responsive non-locals bidders.

The PAFs bidders participating in the tender should submit relevant documents as a proof of PAFs (Project Affected Families) of Dibang Multipurpose Project, NHPC Limited which shall be further duly verified as per the record of the Project. The local bidders participating in the tender should submit documents issued by state government/appropriate authority in support of their being resident of Lower Dibang Valley /Dibang Valley District of Arunachal Pradesh.

2.2.2 Achieved in any one year in last three years (i.e., FY 21-22, FY 22-23& FY 23-24) a minimum Annual construction financial turnover of at least equivalent to the estimated cost of works for which bid has been invited (Rs. 98,60,810/6 i.e. Rs. 16,43,468.00 Per vehicle only).

Satisfactorily completed, in last seven years ending on last day of month previous to one in which applications are invited, at least one similar work/services costing not less than the amount equal to 80% of the estimated cost of work (i.e., Rs. 13,14,774 per vehicle) or two similar works/services costing not less than the amount equal to 50% of estimated cost of work (i.e., Rs. 8,21,734.20 per vehicle) or three similar works services not less than the amount equal to 40% of the estimated cost of works/services (i.e., Rs. 6,57,387.36 per vehicle).

For arriving at the cost of similar work/ services, the value of work/ services executed shall be brought to current costing level by enhancing the actual value of work/services at simple rate of seven percent per annum, calculated from the date of completion to the date of bid opening.

- 2.2.3 All Startups (whether MSEs or otherwise), falling within the definition as per Gazette notification-G.S.R. 501(E) dt. 23.05.2017 or as amended from time to time are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover subject to their meeting the quality and technical specification for which the necessary documents shall be submitted by such bidders. However, the Employer reserves the right to deny such exemptions to Startups (whether MSEs or otherwise) in case of circumstances like procurement of items related to public safety, health, critical security operations and equipments etc. Declaration in this regard is to be submitted by the Bidder as per Annexure-VIII.
- 2.2.4 All Micro and Small Enterprises (MSEs) are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover in public procurement subject to meeting of quality and technical specifications for which necessary documents shall be submitted by such bidders.
- 2.2.5 The reference date for considering the period for eligibility/qualification requirements above shall be the last date of submission of online Bid as per NIT.
- 2.2.6 Each bidder must also produce with their Bid- PAN, Goods & Services Tax Identification No. (GSTIN) (If applicable), EPF Registration No. (if applicable) and ESIC Registration No. (if applicable).
- 2.2.7 Procurement under this tender is reserved for purchase from Class-I local suppliers as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry. The 'Class-I local supplier' at the time of tender or bidding shall be required to indicate percentage of local content and provide self-certification as per Annexure-XIV that the item offered meets the local content requirement for 'Class-I local supplier'. They shall also give details of the location(s) at which the local value addition is made. The directives under public procurement (Preference to Make in India), Order 2017 as amended on 16.09,2020 are indicated in ITB clause 15.
- 2.2.8 In terms of Rule 144 (xi) regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in tender, Bidder has to undertake compliance of this as per Annexure-XV and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws. The provision under Rule 144 (xi) of GFR are indicated in ITB clause 16.
- 2.2.9 As per NHPC policy for Reservation of works for PAFs (Project Affected Families) and Local of Lower Dibang Valley /Dibang Valley District of Arunachal Pradesh at a time not more than 4 (Four) works/ services(vehicle) be allotted/ awarded to the same entity and the value of Works and Services to be awarded to any single entity at any point of time shall be limited to Rs.125 lakhs. Self-declaration in this regard is to be submitted as per enclosed Annexure-XIII. The eligibility of PAF to participate in the tenders shall be considered taking into account the works awarded to PAF's family as a whole. The person, his family along with legal heirs shall be considered as single PAF. Declaration in this regard shall be provided by the PAF as per enclosed Annexure-XIII. In case of false declaration, the concerned PAF shall be debarred from participation of tender for six months.
- 2.2.10 Bidders participating in the tender are required to submit their willingness declaring/mentioning the number of vehicle they are interested to offer. Declaration in this regard is to be submitted as per the enclosed Annexure-XVI. Number of vehicles to be awarded to successful bidder shall be as per the condition/preferences as specified above.
- 2.3 The Bidder should not have been banned / de-listed / black listed / debarred from business or declared ineligible on the grounds mentioned in para 6 of Guidelines on Banning of Business Dealings

2.4 To improve transparency and fairness in tendering process and/or during execution of work undertaken, the Employer is implementing Integrity Pact as per Clause No. 9.0 of the ITB. The bidder must submit the Integrity Pact as per Proforma (Annexure-II) duly signed as per Clause 9.0 of ITB.

Pre-contract Integrity Pact is to be executed on plain paper with NHPC Ltd. at the time of submission of Bids. The successful bidder (Contractor) shall submit duly executed Integrity Pact on Non-Judicial Stamp Paper of appropriate value prior to signing of Contract Agreement.

To oversee the compliance under the Integrity Pact Sh. Prabhash Singh and Dr. Vinod Aggarwal have been appointed as an Independent External Monitor (IEM) by the owner.

- 4.0 NHPC reserves the right to reject any or all tenders and shall not be bound to assign any reason for such rejection.
