Online electronic bids (e-tenders) under two cover system are invited on behalf of Parbati H.E. Project (Stage-II), NHPC Limited (A Navratna Public Sector Enterprise of Government of India) from domestic bidders registered in India on **Open Tender basis** for

2.0 Eligibility Criteria for Bidders:

2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD/ Bid Security (as per Instructions to Bidders (ITB) Clause 3.0 & 4.0) shall not be considered for evaluation., except in case of exemption for only EMD as per Clause No. 4.1 of ITB.

2.2.1 The bidders must fulfil the following minimum Qualifying Criteria: -

(a) Bidder shall be **Class-I Local Supplier** under Public Procurement (Preference to Make in India) order for Goods/ Services/ Works issued by Department of Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry Order No. P-45021/2/2017-PP (BE-II) dated 19th July’ 2024 as amended from time to time. Further, Local content/ Class-I local supplier etc. defined in ITB clause 2.2.4, in this regard bidders must submit undertaking as per **Annexure-X** of ITB.

(b) The bidder should be manufacturer (OEM) of ABT Type Energy Meter.

Or

(c) Authorized dealer / distributor / channel partner / Associate / Collaborator of a manufacturer (OEM) of ABT Type Energy Meter / System may quote on behalf of their manufacturer (OEM) in case manufacturer (OEM) does not quote directly. In such a case, the authorized dealer shall have to submit relevant “Authorized Dealership” certificate from the manufacturer (OEM). (Only agencies/ bidder submitting a general Dealership or Authorization certificate issued by the Manufacturers, **without reference to any specific tender** and having validity of such authorization for the considerable duration shall only be considered for determining the eligibility of the Bidder for the particular tender. Authorization issued with reference to the specific tender in favour of particular dealer/bidder will not be entertained).

In case a dealer/ distributor/ channel partner/ Associate / Collaborator is participating in a tender on behalf of one manufacturer, he is not allowed to participate / quote on behalf of another manufacturer in this tender or in a parallel for the same item. All such bids with same make/ manufacturer will be rejected.

- (d) A valid ISO certification of manufacturer for manufacturing the specified equipment/ system/ item i.e. ABT Type Energy Meter should be submitted with the bid.
- (e) The bidders should have successfully executed/ completed contract as mentioned below for the **similar items** i.e. **“Supply, Installation, Testing and Commissioning of ABT type energy meters” during last five/Seven years ending last day of month** previous to the one in which tenders are invited:-
 - i) One Contract/ Supply Order of at least **Rs. 29.22 Lakh Or**
 - ii) Two Contract(s) / Supply Order(s) each costing at least **Rs. 18.26 Lakh Or**
 - iii) Three Contract(s) / Supply Order(s) each costing at least **Rs.14.60**

Similar items referred above shall means **“Supply, Installation, Testing and Commissioning of ABT Type Energy Meters”**

The bidder shall provide with their Techno-Commercial Bid, **notarized copy** of Letter of Award/ Supply Order, Bill of Quantities and execution/ completion certificate issued by the purchaser/ owner against above contract. In case Purchaser/Owner issuing execution/ installation/commissioning certificate is non-government entity, the bidders shall also submit notarized copy of TDS Certificate.

For arriving at the cost of similar work, the value of work executed shall be brought to current costing level by enhancing the actual value of work at simple rate of seven percent per annum, calculated from the date of completion to the date of bid opening.

- (f) Average Annual Turnover during last 3 years, ending **31st March 2024** should not be less than **Rs.11.00 Lakh**. The bidder shall submit duly **notarized** copy of Auditor’s reports/audited Balance sheet & Profit Loss account for the last three financial years or Certificate from Chartered Accountant in respect of Annual Turnover during last 3 years, ending **31st March 2024** along with copy of ITR to prove financial standing of the bidder.

2.2.4 The reference date for considering the period for eligibility / qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.

2.2.5 The bidder should submit copy of PAN Card, Goods & Services Tax Identification No. (GSTIN) and EPF Registration No..

2.2.6 The bidder should submit copies of original documents defining the constitution or legal status, place of registration and principal place of business and notarized copy of power of attorney of the signatory of the Bid to commit the Bidder.

2.3 The Bidder should not have been banned / de-listed / black listed / debarred from business or declared ineligible on the grounds mentioned in ITB Cl. No. 12.0(d) or para 6 of Guidelines on Banning of Business Dealings (Annexure-A) to Integrity Pact, ITB Clause 8.0. Self-declaration in this regard is to be submitted as per enclosed Annexure-III.

2.5 Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the contract. Bidders will submit duly notarized requisite supporting documents and testimonials with their Bids to prove their credentials and claim of meeting the Eligibility Criteria.

3.0 In the event of the specified date for the submission of offline documents being declared a holiday for the Employer, the hard copies of the documents will be received up to the specified time on the next working day. However, the date and time for online submission of the bids shall continue to be the date and time specified above or any amendment for the same.

- 4.0 Online submission of the Bids (incl. attachments) will not be permitted on the portal after expiry of submission time and the Bidders shall not be permitted to submit the same by any other mode. In such case, even if the bidder has submitted the specific documents in hard copy (ies) in original within the stipulated deadline, its bid shall be considered as late and shall not be considered at all any further. Offline documents, if received by the Employer after the deadline for submission of hard copies, then it will be considered as late bid even if the bidder has uploaded the bid online within the deadline. In such a case, the bid uploaded on the portal shall not be considered at all any further.
- 5.0 At any time prior to the deadline for submission of bid, the Employer may amend the Tender Document by issuing corrigendum/addenda/amendment which shall be notified on portal <http://eprocure.gov.in/eprocure/app> & NHPC website www.nhpcindia.com. Therefore, the bidders are advised to visit the site regularly before deadline for submission of bids. Bidder is required to acknowledge the receipt of any such amendment from the CPP Portal. It will be presumed that the amendment has been accepted and the information contained therein has been taken into account by the Bidder in its bid. The bidders are requested to see the web site once again before the due date of tender submission/ opening to ensure that they have not missed any corrigendum/ addendum uploaded against the said tender after downloading the tender document.
- The responsibility of downloading the related corrigendum/ addendum, if any, will be that of the downloading firm/prospective bidder.**
- 6.0 Bids will be opened as per the schedule at the aforesaid venue. In case the office of Employer happens to be closed or in-advertent condition of non-availability/ non-working of Central Public Procurement (CPP) portal or for any other reason on the date of opening of bid as specified, the bid will be opened on the next working day at the same time and venue.
- 7.0 Tenderer who has downloaded the tender from the NHPC website www.nhpcindia.com or Central Public Procurement Portal (CPPP) website <http://eprocure.gov.in/eprocure/app>, shall not tamper/modify the tender document including downloaded price bid template in any manner. In case if the same is found to be tempered/ modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with NHPC.
- 8.0 The details/ information regarding online tendering i.e. Registration on CPP portal, Preparation of Bid and Submission of bid are available in the tender document and as well as on CPP Portal under "Bidders Manual Kit".
- 9.0 NHPC reserves the right to reject any or all tenders and shall not be bound to assign any reason for such rejection.
