The definition of Project affected families (PAFs) shall be as per definition pr ovided in the "Right to Fair Compensation and Transparency in Land Acquisiti on, Rehabilitation and Resettlement Act, 2013" and subsequent amendments, if any.

The definition of Project affected families (PAFs) in relation to land for NHP C is as below:

(vi) a family residing on any land in the urban areas for preceding three years or more prior to the acquisition of the land or whose primary source of livelihood for three years prior to the acquisition of the land is affected by the acquisition of such land.
