2. The bidder should submit work experience of similar works executed during the last 7(Seven) years , supported by award letter and completion certificate by EIC/project authority needs to be submitted by the bidder along with techno-commercial document.
3. **In case of experience certificates produced by the contractors for having executed works for Private Organizations, TDS Certificate shall be produced along with experience certificate.**

Establishment Criteria:

Bidder shall have their registered office / local office in the district of Namchi / Geyzing, in state of Sikkim, at the time of submission of bid. Documentary evidences in this regard shall require to be submitted along with Bid. Any undertaking in regards to opening of his registered office / local office, after submission of bid, will not be entertained by employer. If registered office / local office as above, is not convinced / evident during bid evaluation, their bid will liable to be rejected.
