**6.0 Liquidated Damages:** If the Supplier fails to attain completion of the s upply of the material (including installation, testing and commissioning of items /equipments) or any part thereof within the prescribed time for completion und er clause 5.0 or any extension thereof (due to delays not attributable to the Sup plier), the Supplier shall pay to the Purchaser liquidated damages equal to the amount computed @ 1/2 (half) percent per week or part thereof of Contract Pri ce.
