 - (B) Utmost care shall be taken by bidder/seller while uploading technical bid documents at GeM Port al that it should not contain "Financial offer/Price bid" in any form. The bidder/seller are caution ed that uploading financial offer or disclosing/revealing its quoted price in any form in its technical bid document will result in rejection of tender.
- 1.3. Bids of those Bidders who have not submitted the EMD as sought under "EMD Details of Bid Doc ument" shall not be considered for evaluation, except in case of exemption. The bidder seeking EMD exemption, must submit the valid supporting document for the relevant category as per G eM GTC with the bid.
