## (Bid of PAF/Local bidders shall be technically evaluated and bid of other non-PAF/non-Local bid ders shall be summarily rejected in technical evaluation.)

This work is reserved for PAFs and locals residing near to the Power Station. Definition of Project Affected F amily (PAFs) shall be as per the definition provided in the "Right to fair compensation and transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and subsequent amendment, if any. The detai led definition in respect of PAFs and Locals for NHPC is specified in Annexure-A.

# Eligibility criteria for this work/ service for Project Affected Family (PA Fs) and locals shall be as under:

- (i) PAFs, Individuals, partnership firms, group of people in the form of Cooperative Societies/ Self Help Gro ups (SHGs) by locals from the notified areas will only be considered.
- (ii) The provisions regarding Micro and Small Enterprises and Start-ups shall be applicable.
- (iii) For benefit of larger population of nearby area of Power Station, at a time not more than 04 works/services to be allotted/awarded to the same entity. Financial limit of award to any single entity at any point of time for works and services shall be limited to Rs. 125 lakhs. The reference date for consid ering the eligibility for bidders as PAF/Locals shall be the last date of the submission of the online bid.
- (iv) In the event of non-participation of PAFs/ Locals in the 'Local Competitive Bidding' process for the liste d works, then HOP shall records circumstances/ reasons for such non-participation and may initiate th e process afresh to award such works on Open Tender Basis.

# (v) Bidder should submit documental proof for PAFs and /or Locals as following 02 documents:

# a) Domicile Certificate of Kathua District of J&K and

b) Ration Card / Voter ID Card .

(vi) Bidder should submit details of awarded active work with duration of period dealt with Sewa-II PS under work reserved for PAFs and/or Locals.

# **Definition of Project Affected Families (PAFs) and Locals**

# A. Definition of Project Affected Families (PAFs)

- (i) a family whose land or other immovable property has been acquired;
- a family which does not own any land but a member or members of such family may be agricultura I labourers, tenants including any form of tenancy or holding of usufruct right, share-croppers or arti sans or who may be working in the affected area for three years prior to the acquisition of land, who se primary source of livelihood stand affected by acquisition of land;
- the Scheduled Tribes and other traditional forest dwellers who have lost any of their forest rights re cognized under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Ri ght) Act 2006 due to acquisition of land;
- (iv) family whose primary source of livelihood for three years prior to the acquisition of land is depende nt on forests or water bodies and includes gatherers of forest produce, hunters, fisher folk and boat men and such livelihood is affected due to acquisition of land;
- (v) a member of the family who has been assigned land by the State Government or the Central Gover nment under any of its schemes and such land is under acquisition;
- (vi) A family residing on any land in the urban areas for preceding three years or more prior to the acq uisition of land is affected by the acquisition of such land.

# B. Definition of Locals

# The geographical limits for defining the local residents eligible unde r the policy at the individual Project/Power Station shall be district(s ) where the Projects and its components are located. In case of Sew a-II PS, local residents shall be from District - Kathua (J&K).

# C. Eligibility:

i. PAFs in the form of Individuals, partnership firms, group of people in the form of Cooperative societies/ S elf Help Groups (SHGs)/ Companies (having 100% beneficiaries from the category og PAFs/Locals) by local s from the notified area will only be considered under the policy for award of the reserved works/services. The eligibility of PAF to participate in the tenders shall be considered taking into account the works awarded to PAF's family as a whole. The person, his family along with legal heirs shall b e considered as single PAF. Declaration in this regard shall be provided by the PAF. In case of fa lse declaration the concerned PAF shall be debarred from participation of tenders for six months.

## 1. The bidders must fulfil the following minimum Qualifying Criteria:

All bidders shall include the following information and documents with their bids in, qualification Inform ation unless otherwise stated:

- (a) Copies of original documents defining the constitution or legal status, Memorandum of Understandi ng & Articles of Association, place of registration and principal place of business; written Power of Att orney along with a copy of board resolution. In case of General Power of Attorney, a true copy of the POA shall be notarised/ self-attested and in case of a specific Power of Attorney, the original POA.
- (b) Work experience of minimum one year supported by satisfactory performance/completi on certificate to demonstrate meeting the criteria stipulated below as Clause d(i). The wo rk experience shown shall be supported with certificate(s) from the Engineer-in-charge/Project Head of the concerned work. In case the contractor produces the experience of a private work, the TDS ce rtificate shall be submitted to establish that the particular work of particular value has actually been done by the contractor.

On-going works continued beyond original contract period/ extensions (if any), as on stipulated date shall be considered for evaluation. However, the actual executed value of work done beyond the ori ginal contract period will not be considered for evaluation purpose.

- (c) Information on financial criteria i.e. Achieved in any one year in last three year a minimum Annua I construction turnover of at least equivalent to the estimated cost of works i.e. Rs. 68,42,061/- for which bid has been invited. Last three years are FY 2022-23, 2023-24 & 2024-25. Copy of Certifica te of CA mentioning Financial Turnover of last 3 (three) years is required to submit for ascertaining the bidder's meeting the financial criteria.
- (d) To qualify for award of the Contract, bidder should have:
- (i) Satisfactorily completed as Prime Contractor at least one similar work equal in value to 80% of estimated cost (₹ 54,73,649.00) or two works equal in value to 50% of estimated cost (₹ 34,21,031.00) or three works equal in value to 40% of estimated cost (₹ 27,36,824.00) in last seven (07) years.

**Similar nature of work means:** Providing services for running and maintenance of township/ colony/ roa d/ various complex/ park/ water supply system and other miscellaneous running and maintenance works.

2. The previous financial year means the Financial Year previous to the year of issue of NIT.

3. The reference date for considering the period for eligibility/ qualification requirements above shall be th e last day of the month previous to the one in which tenders are invited.

4. Bidder should submit documental proof for PAFs and /or Locals as following 02 documents:

a) (i) Domicile Certificate of Kathua District of J&K and (ii) Ration Card / Voter ID Card.

b) Bidder should submit details of awarded active work with duration of period dealt with Sewa-II PS u nder work reserved for PAFs and/or Locals.

**Note:** In case the bidder does not cover under ESIC including the present contract as per the ESI Act then he should submit an undertaking in this regard. Further, in case the bidder is covered under ESI but not ha ving the ESIC then he may submit the undertaking that in case the bidder is found as L-1, then such L-1 bid der will submit the required ESIC document before issuing of Letter of Intent/ Letter of Award.

7. Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the Contract. Bidders will submit duly notarised/ self-attested requisite supporting documents i.e. documents defining the constitution or legal status, place of registration and principal place of business, written Power of Attorney along with a copy of board resolution and testimonials with their Bid s to prove their credentials and claim of meeting the Eligibility Criteria.

8. In case of wage revision, EPF, EDLI, Admin Charges, ESI, Optional Allowances 1 (Gratuity & Leave) shall be revised accordingly. However, Optional Allowances 2 (Conveyance) & Optional Allowances 3 (Consumables & PPEs) shall remain constant.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा ।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
