1.0 Eligibility Criteria for Bidders:

1.1 Bids of those Bidders who have not submitted the hard copy of Earnest Money Deposit (EMD) shall not be considered for evaluation. Separate Earnest Money Deposit (EMD) is required to subm it for bidding each vehicle as tabulated below.

EMD EXEMPTION: The bidder seeking EMD exemption, must submit the valid supporting document for th e relevant category as per GeM GTC with the bid. Under MSE category, only manufacturers for goods of Pri mary Product Category and Service Providers for Services of Primary Product Category are eligible for exe mption from EMD. MSE Services (Trading) are not eligible for EMD exemption.

- 1.2 The provisions regarding Micro and Small Enterprises, Make in India and Start-ups shall be applicab le.
- 1.3 The Bidder should quote only fixed charge for 24 Months (excluding GST).

1.4~ The manufactured Model of the offered vehicle should not be older than year 2024.

- **1.5** Bid Specific ATC i.e. Annexure-I to IV and Special Conditions of Contract to be filled, signed and upl oaded online by the Bidder.
- 1.6 The eligibility of PAF to participate in the tenders shall be considered taking into account the works awarded to PAF's family as a whole. The person, his family alongwith legal heirs shall be considered as single PAF. Declaration in this regard (Annexure-III) shall be provided by the PAF. In case of false declaration, the concerned PAF shall be debarred from participation of tenders for six months.
- 1.7 This work is reserved for PAFs of Sewa-II Power Station. Definition of Project Affected F amily (PAFs) shall be as per the definition provided in the "Right to fair compensation an

d transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and subse quent amendment, if any. The detailed definition in respect of PAFs for NHPC is specified as below: -.

Definition of Project Affected Families (PAF) of NHPC, Sewa-II Power Station

- i. a family whose land or other immovable property has been acquired;
- ii. a family which does not own any land but a member or members of such family may be agricultu ral labourers, tenants including any form of tenancy or holding of usufruct right, share-croppers o r artisans or who may be working in the affected area for three years prior to the acquisition of la nd, whose primary source of livelihood stand affected by acquisition of land;
- the Scheduled Tribes and other traditional forest dwellers who have lost any of their forest rights recognized under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Fore st Right) Act 2006 due to acquisition of land;
- iv. family whose primary source of livelihood for three years prior to the acquisition of land is depen dent on forests or water bodies and includes gatherers of forest produce, hunters, fisher folk and boatmen and such livelihood is affected due to acquisition of land;
- v. a member of the family who has been assigned land by the State Government or the Central Gov ernment under any of its schemes and such land is under acquisition;
- vi. a family residing on any land in the urban areas for preceding three years or more prior to the ac quisition of land is affected by the acquisition of such land.

1.8 Documentary proof for PAFs: PAF/ Oustee Certificate/Statement of acquiring the land of applicant by NHPC Ltd. for constructing Sewa-II Power Station issued by Tehsildar/SD M of State Government.

- 1.9 For benefit of larger population of nearby area of Power Station, at a time not more than 4 (four) w orks/ services be allotted/ awarded to the same entity. Financial limit of award to any single entity at any point of time of work & service shall be limited to Rs. 125 lakhs. The reference date for considering the eligibility for bidders as PAF/ Locals shall be the last date of the submission of the online bid.
- 1.10 Details of ongoing contracts awarded to applicant by Sewa-II Power Station under works reserved for PAFs and/or Locals, need to be furnished (Annexure-I).
- 1.11 The Bidders(s) whose contract(s) has been terminated due to poor performance by the Employer, shall not be allowed to participate in the bidding process for next 2 years w.e.f. the date of notificati on of termination.
- 1.12 Proof of ownership & Photocopy of all documents of the vehicle such as Ownership, Registration Ce rtificate, Insurance and Road Permit etc. shall be submitted with the tender. In case, any bidder, int ends to purchase the vehicle on a later date and interested to participate in above Tender, shall su bmit an undertaking on non-judicial stamp paper of Rs 100/- duly attested by Notary (Ref. Annexure-IV) that they will produce the vehicle along with required documentation of the vehicle, wi thin 60 days from the date of issue of letter of intent (LOI). In case of failure of the bidder to submit t he required documents, within time, NHPC reserves the right to forfeiture of its Bid security and term inate the award offer.
- 1.13 PAN and Goods & Services Tax Identification No. (GSTIN). However, as per Government of India not ification, "those person/firm/supplier, who are unregistered with GST can provide intra state/ intersta te services to a GST registered person/firm". If this condition is not extended by the Government of I ndia, then GST registration shall be required for all service providers. Therefore any bidder, who are not registered with GST, but interested to participate in above NIT, shall submit an undertaking on n on-judicial stamp paper of Rs 100/- duly attested by Notary (Ref. Annexure-IV) that they will register with GST (intra state/ interstate, as the case may be). In case of failure of the bidder to submit the re quired documents of GST registration GST registration within 1 month from the date of notification, NHPC reserves the right to reject the bid/contract and to forfeiture of its Bid security.
- 1.14 The Bidder should not have been banned/ de-listed/ black listed/ debarred from business or decla red ineligible on the grounds mentioned in para 6 of Guidelines on Banning of Business Dealings (An nexure-A) to Integrity Pact [if applicable]. Self-declaration in this regard is to be submitted as per en closed Annexure-II.
- 1.15 Integrity Pact To improve transparency and fairness in the tendering process and/or during exe cution of work undertaken, the Purchaser is implementing **Integrity Pact**. The bidder must submit d uly signed Integrity Pact as per Proforma.
- **1.16** Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be consider ed for evaluation and award of the Contract.
- 1.17 NHPC reserves the right to reject any or all tenders and shall not be bound to assign any reason f

or such rejection.

2 Evaluation of Bid

Work is reserved for project affected families (PAFs) only and at a time not more than 4 (four) works/ services be allotted/ awarded to the same entity.

2.1 In case 1 or more than 1 work/service has already been awarded to a bidder by Sewa-II Power St ation, then the bidder will be asked to confirm the name of maximum 3 vehicles (item wise) for whic h they want to participate and their other bids for instant tender shall be rejected.

2.2 If the bidder has already been awarded four work/service from Sewa-II Power Station, their bid fo r instant tender shall be rejected.

2.3 vehicles (item wise) lowest bid will be selected for award.

3 Guidelines for finalizing the award process:

Letter of Intent will be issued to L-1 bidder for the bid. In case, the L1 bidder failed to provide the ser vice within stipulated time, the LOI will be cancelled and offer may be given to next bidder. Such aw ard to next bidder (in order of preference of their quoted rates) shall be done only after his/her writt en consent that he/she is interested to provide the vehicle at L-1 rate.

8. Purchase Preference (Centre)

The minimum local content to qualify as a class 1 local supplier is denoted in the bid document 50%.
