Balance 30% of the supply portion and 100% of Installation, Testing & Commissioning will be paid after successful installation & Commissioning of mat erial as per direction of Engineer-in-Charge.

2.0 Inspection:

- a) Inspection shall be carried out by authorized representative of purch aser at firms's premises before dispatch of material. The firm shall submit the details of the material along with the time schedule in which the ord ered material shall be offered for inspection along with the place of inspection. The supplier shall give intimation/inspection at least before 3 weeks prior to the date of inspection.
- b) The manufacturer/supplier shall depute their authorized service engineer/personnel for dismantling existing relays, successful installation, testing & commissioning and functional demonstration of all useable features of Numerical Shunt Reactor Protection Relays to the satisfaction of Engineer-In-Charge. Installation, Testing & Commissioning at site shall include complete protection, operational checks & any other test (if required). All tests shall be witnessed by both representatives of NHPC & manufacturer/supplier and detailed test report shall be submitted to NHPC.

c) For the offline testing & online testing of the supplied relays at site, t he relay testing kit shall be provided by NHPC to the service engineer.

5.2 On due completion and commissioning of work in all respect and on ex piry of the warranty period as per clause 10, the bank guarantee shall be returned to the contractor without any interest on presentation of a n absolute "No Demand Certificate" from the Purchaser and upon the r eturn, in good conditions, of any Specifications, Drawings, tools or tack les or any other property belonging to the Purchaser which may have been issued to the Contractor. Provided always that the Purchaser shall

I be entitled to retain, set off, deduct or adjust any claim against the C ontractor from the money deposited with or becoming payable by the Purchaser.

6.0 Completion Period/Delivery Period:

The installation and commissioning of Numerical Shunt Reactor Protection R elays, being a predominantly indoor work is proposed to be carried out durin g lean season (i.e. October March).

Total time of completion:

Time is the essence of the contract.

- a) **Delivery time:** The total completion period for submission & approval of drawings, design, manufacture and supply of material at Uri Power Station s hall be 120 days from the date of issue of LOA. Any delay on part of NHPC s hall be excluded from completion period. The date of delivery shall be recko ned from the day of issue date of supply order.
- **b) Installation, Testing & Commissioning:** The installation & commissioning of the supplied relays along with the retrofitting material shall be taken up by the supplier. The supplier shall be liable to depute company's authorized personnel to project site for the successful installation & commissioning of supplied relay within **60 (Sixty) days** from the date of intimation (through Email) when the site shall be ready for installation & commissioning.

The actual date of deputation of Service Engineer for commissioning shall ho wever be carried out in consultation with Engineer-In-Charge as per site req uirement & availability of 400KV transmission line shutdown. Necessary shut down from NRLDC/ Powergrid shall be made available to the bidder/firm by NHPC during the erection of the old relay and also during the final commissi oning period.

7.0 Liquidated Damages:

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the B uyer will be entitled to deduct/recover the Liquidated Damages for the delay , unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed per iod as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

8.0 Agreement

8.1 After issue of the Letter of Intent / Award, the Purchaser shall prepare t he Agreement on the stamp paper on the Form enclosed as Annexure C for Supply & Erection contracts and the parties shall sign the said Agree ment within 30 Days from the date of issue of Letter of Intent / Award. T

he expenses of completing and stamping the agreement shall be borne by the Contractor. The Contractor shall furnish 3 sets of such Contract A greements to the Purchaser. After the Agreement, one original set shall be handed over to the Contractor and the remaining two sets shall be re tained by the Purchaser.

8.2 After the bid has been accepted by the Purchaser, all orders or instruct ions to the Contractor shall, except as herein otherwise provided, be giv en by the Engineer-in-Charge or his authorised representative, in writing , on behalf of the Purchaser.

9.0 Integrity Pact

To improve transparency and fairness in tendering process the Purchaser/ E mployer is to implement a transparency pact. The Pre-Contract integrity pact, signed by all the bidder and the Purchaser/ Employer shall commit the persons/officials of both the parties, not to exercise any corrupt/fraudulent/collusive/coercive practices in the tendering process and also during implementation of the contract.

10.0 Warrantee:

The equipment/ items shall be warranted against poor quality or workmansh ip of material or manufacturing defects for a minimum period of 12 months commencing upon the setting to work of item/ plant or 18 months from the date of despatch whichever is earlier. During the Warrantee period the Supp lier shall repair/replace the defected items free of cost and no conveyance or any other charges shall be paid. If any defect is not remedied within a reas onable time, the Purchaser may proceed to do the work at the Supplier's risk and expense, but without prejudice to other rights, which the Purchaser may have against the Supplier in respect of such defects

11.0 <u>Transit Insurance:</u>

Transit Insurance shall be borne by the Supplier.

of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
