1. Buyer Added Bid Specific ATC

This case is being floated on Proprietary Article Certificate (PAC) Basis and reserved for Origin al Equipment Manufacturer (OEM) of the system/equipment i.e. M/s. Apollo Fire Alarm System or their authorized dealer/service provider.

1. The bidders must fulfil the following minimum Qualifying Criteria:

All bidders shall include the following information and documents with their bids in, qualification Inform ation unless otherwise stated:

(a) Copies of original documents defining the constitution or legal status, Memorandum of Understandi ng & Articles of Association, place of registration and principal place of business; written Power of Att orney along with a copy of board resolution. In case of General Power of Attorney, a true copy of the

POA shall be notarised/ self-attested and in case of a specific Power of Attorney, the original POA.

- (b) Work experience supported by satisfactory performance/completion certificate to demo nstrate meeting the criteria stipulated below as Clause d(i). The work experience shown shall be supported with performance/completion certificate(s) from the Engineer-in-charge/Project H ead of the concerned work. In case the contractor produces the experience of a private work, the TD S certificate shall be submitted to establish that the particular work of particular value has actually been done by the contractor.
- (c) Information on financial criteria i.e. Achieved in any one year in last three year a minimum Annua I turnover of at least equivalent to the estimated cost of works i.e. Rs. 9,60,166/- for which bid has been invited (Last three years are FY 2022-23, FY 2023-24 & FY 2024-25). Copy of Certificate of CA mentioning Financial Turnover along-with Balance Sheet & Profit and Loss statemen t of last 03 (three) years is required to submit for ascertaining the bidder's meeting the financial criteria. The CA Certificate should have the Unique Document Identification Number (UDIN) as per Gazette Notification No. 1-CA(7)/192/2019 dated 02.08.2019.
- (d) To qualify for award of the Contract, bidder should have:
 - (i) Satisfactorily completed as prime contractor at least one similar work equal in value to 80% (Rs. 7,68,133/-) of the estimated cost of work or two similar works costing not less than the amount equal to 50% (Rs. 4,80,083/-) of estimated cost of work or three similar works not less than the amount equal to 40% (Rs. 3,84,066/-) in last seven (07) years.

Similar nature of work means: Supply, installation and commissioning of Addressable fire alarm/detect ion system OR Repair of Addressable fire alarm/detection system.

- The bidder shall submit the technical specification/ Technical Brochure and Make & Model of items alon g with the bid.
- 2. The previous financial year means the Financial Year previous to the year of issue of NIT.
- 3. The reference date for considering the period for eligibility/ qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.
- 4. Each bidder must also produce with their Bid :-
 - · PAN;
 - · Goods & Services Tax Identification No. (GSTIN);
 - EPF Registration No.;
 - ESIC Registration No.;
 - Bank Account details;
 - · Annexure-I, II, III, IV, V on their letter head;
 - Acceptance of Scope of work
 - Acceptance of Special Conditions of Contract (SCC);

Note: In case the bidder does not cover under ESIC including the present contract as per the ESI Act then he should submit an undertaking in this regard. Further, in case the bidder is covered under ESI but not ha ving the ESIC then he may submit the undertaking that in case the bidder is found as L-1, then such L-1 bid der will submit the required ESIC document before issuing of Letter of Intent/ Letter of Award.

5. Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the Contract. Bidders will submit duly notarised/ self-attested requisite supporting documents i.e. documents defining the constitution or legal status, place of registration and principal place of business, written Power of Attorney along with a copy of board resolution and testimonials with their Bid s to prove their credentials and claim of meeting the Eligibility Criteria. All uploaded documents of bid shall be signed along with seal of the authorized person of the company.

3. Certificates

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The

Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
