#### 1. Buyer Added Bid Specific ATC

- 1.1. Online electronic bid (e-tender) at GeM portal is invited through **Local competitive bidding reserve d for Project Affected Families (PAF) and/or Local** under "Two Packet Bid system" for and on behalf of NHPC Limited (A Public Sector Enterprise of the Government of India) from eligible sole bidder for the work of "Providing Services for Up-keeping of Field Hostel/ Transit camp and R&M of Residential and Non Residential Buildings and Garden at Sainj and Sallah of Parbati-III Power Station".
- **1.2.** (A) Instant bid type is "Two Packet Bid", so bidder/seller is advised to upload/quote financial offer in it s financial bid only as where applicable at GeM Portal.
- (B) Utmost care shall be taken by bidder/seller while uploading technical bid documents at GeM Portal that it should not contain "Financial offer/Price bid" in any form. The bidder/seller are cautioned that uploading financial offer or disclosing/revealing its quoted price in any form in its technical bid document will result in rejection of tender.
- 1.3. Bidder can also submit the EMD in the form of Bank Guarantee issued by an Indian Nationalized Bank or any Scheduled Bank in India in the prescribed proforma, annexed as "Annexure-IV" under "Buyer Uploa ded ATC Document", valid for a period not less than 90 days beyond the validity period of the tender.

#### 1.4. Eligibility Criteria for Bidder:

- (A) Project Affected Families (PAFs) / Locals from the notified area of project will only be considered under the policy for award of the reserved works / services as per "Section-IV" of Buye r Uploaded ATC Document.
- (B) Bids of those Bidders who have not submitted the EMD as sought under "EMD Details of Bid Document" shall not be considered for evaluation, except in case of exemption. The bidder seeking EMD exemption, must submit the valid supporting document for the relevant category as per GeM GTC with the bid. Under MSE category, only Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy.
- (C) All bidders meeting Qualification criteria as defined in clause 1.5.

#### 1.5. **Qualification Criteria**

i. Average annual financial turnover during the last three (03) financial years ending 31st March of pre

- ii. The Bidder must have successfully executed /completed at least one single order of 80 % of the Ann ualized Estimated Cost or 2 orders each of 50 % of the Annualized Estimated Cost or 3 orders each of 40 % of the Annualized Estimated Cost for similar service(s) in last Seven (07) years.
  - · (Similar Service is defined as "Deployment of Manpower for R&M/Cleaning, Sweeping /U p-Keeping works").
  - · (Annualized Estimated Cost= Total Estimated Cost/ Period of Completion in years (n))

(In case period of the completion is less than 1 year then value of (n) will be considered as 1)

- iii. Copies of contracts / work orders for satisfactorily completed or satisfactory performance certificate is sued by the employer for the work done/performed, for not less than one year as a Prime Contractor in sup port of requisite past experience of Similar Services as at Sl.No. (ii) is to be uploaded with the bid for verific ation by the Buyer.
- iv. In case of experience certificates produced by the bidders for having executed works/service for Priva te Organizations, TDS Certificates/Annual Information Statement(AIS)/Form 26AS shall also be produced all ong with experience certificates. The reference date for considering the period of preceding Seven (07) Ye ars for general & specific technical experience shall be the last day of the month previous to the one in which Tenders are invited.
- v. If the bidder is a Startup/Micro or Small Enterprise as per latest definition under MSME rules, the bidd er shall be exempted from the requirement of "Prior experience –Prior Turnover" subject to meeting of qua lity and technical specifications. In case any bidder is seeking exemption from "Prior experience –Prior Turn over" the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- vi. For benefit of larger population of PAFs/Locals of Parbati-III Power Station, at a time not more than 04 works/services be allotted / awarded to the same entity.
