- (b) Work experience supported by satisfactory performance/completion certificate to demo nstrate meeting the criteria stipulated below as Clause d(i). The work experience shown shall be supported with performance/completion certificate(s) from the Engineer-in-charge/Project H ead of the concerned work. In case the contractor produces the experience of a private work, the TD S certificate shall be submitted to establish that the particular work of particular value has actually been done by the contractor.
- (c) Information on financial criteria i.e. The average annual financial turnover during the last three ye ars ending 31st March of the previous financial year to the year of NIT should be at least ₹ 13,91,3 38.00, 30% of estimated cost (Last three years are FY 2022-23, FY 2023-24 & FY 2024-25). The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
