#### 1. The bidders must fulfil the following minimum Qualifying Criteria:

All bidders shall include the following information and documents with their bids in, qualification Inform ation unless otherwise stated:

- (a) Copies of original documents defining the constitution or legal status, Memorandum of Understandi ng & Articles of Association, place of registration and principal place of business; written Power of Att orney along with a copy of board resolution. In case of General Power of Attorney, a true copy of the POA shall be notarised/ self-attested and in case of a specific Power of Attorney, the original POA.
- (b) Work experience of minimum one year supported by satisfactory performance/completi on certificate to demonstrate meeting the criteria stipulated below as Clause d(i). The wo rk experience shown shall be supported with certificate(s) from the Engineer-in-charge/Project Head of the concerned work. In case the contractor produces the experience of a private work, the TDS ce rtificate shall be submitted to establish that the particular work of particular value has actually been done by the contractor.
- (c) Information on financial criteria i.e. Achieved in any one year in last three year a minimum Annua I turnover of at least equivalent to the estimated cost of works i.e. Rs. 12,38,292/- for which bid ha s been invited. Last three years are FY 2022-23, 2023-24 & 2024-25. Copy of Certificate of CA men tioning Financial Turnover along-with Balance Sheet & Profit and Loss statement of last 03 (three) years is required to submit for ascertaining the bidder's meeting the financial criteria. The CA Cer tificate should have the Unique Document Identification Number (UDIN) as per Gazette Notification No. 1-CA(7)/192/2019 dated 02.08.2019.
- (d) To qualify for award of the Contract, bidder should have:
- (i) Satisfactorily completed as Prime Contractor at least one similar work equal in value to 80% of estimated cost (₹ 9,90,634.00) or two works equal in value to 50% of estimated cost (₹ 6,19,146.00) or three works equal in value to 40% of estimated cost (₹ 4,95,317.00) in last seven (07) years.

- 2. The previous financial year means the Financial Year previous to the year of issue of NIT.
- 3. The reference date for considering the period for eligibility/ qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.

- 5. Bids of only those Bidders who are meeting the Eligibility Criteria specified above will be considered for evaluation and award of the Contract. Bidders will submit duly notarised/ self-attested requisite supporting documents i.e. documents defining the constitution or legal status, place of registration and principal place of business, written Power of Attorney along with a copy of board resolution and testimonials with their Bid s to prove their credentials and claim of meeting the Eligibility Criteria.
- 6. **CONTRACT AGREEMENT:** Contractor should submit the non-judicial stamp paper worth Rs.100/- of UT of J&K for preparing agreement as well as sign the a greement within 28 days from the date of issue of LOA otherwise L.D. of ₹500.0 0 (Rupees Five Hundred only) per day subject to maximum ₹5000.00 (Rupees Five Thousand Only) shall be levied.
- 7. **PERFORMANCE SECURITY DEPOSIT:** Bidder should submit the Applicable Performance Security/Security Deposit as per GeM clause is required to submit within 28 days from the date of issue of LOA by the contractor. In case, the cont ractor does not submit requisite performance security without a valid reason, the Employer shall impose simple interest @ 12% per annum on the full amount of applicable performance security (along-with applicable taxes, if any) for the period of delay in submission of performance security.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
