y valid reason, Tender Inviting Authority may grant time extension for submission of performance security based on the request of Contractor. In case, the Contractor does not submit performance security without a valid reason, the Employer shall impose simple interest @12% per annum on t he full amount of applicable performance security (along with applicable taxes, if any) for the peri od of delay in submission of performance security. The interest on delayed period shall be calcul ated on pro rata basis for number of delayed days.

The interest accrued shall be payable by the Contractor within 14 days from the date of intimatio n by Tender Inviting Authority in form of Bank Demand Draft/ Banker Cheque in favour of 'NHPC Ltd', otherwise the same shall be recovered from any payment due or become due against bills / any other amount lying with NHPC.

The performance security will be forfeited and credited to the procuring entity's account in the e vent of a breach of contract by the contractor. It should be refunded to the contractor without int erest, after he duly performs and completes the contract in all respects but not later than 90 (nin ety) days of completion of all such obligations including the warranty

under the contract. Return of Bid/ Performance Securities should be monitored and delays should be avoided. If feasible, the details of these securities may be listed in the e-Procurement Portal, s o make the process transparent and visible.

d) The Insurance Surety Bonds as security instrument for Performance Security shall be applicable in all tenders and shall be governed as per Circular No. CCW/2023/194 dated 01.12.2023 and CC W/2024/200 dated 19.02.2024. The irrevocable Insurance Surety Bond issued by an Indian Insurance Company registered under Insurance Act 1938 or as amended from time to time and approved by the Insurance Regulatory Development Authority of India (IRDAI) in Indian Currency (INR) only shall be acceptable.

6.0 Completion Period:

The total completion period of 60 (Sixty) days from the date of issue of Supply Order/Purchase Order for complete Scope of Work covered under the

contract. shall be as follows:

_

i) For supply, installation, testing and commissioning—3 (three months) from the date of start of work as mentioned in Letter of Award (LOA) which includes supply of material at site, installation of equipment and 15 days trial run. All permission required for installation at predetermined site shall be the responsibility of project authorities.

_

ii) 02 (Two) years onsite comprehensive warranty from date of commissioning i.e. after completion of 15 days un-interrupted trial run of system.

_

iii) Annual Maintenance (AMC) Period - 03 (Three) years from the date of expiration of the two years' warranty period as mentioned in (ii) above

7.0 Liquidated Damages:

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the B uyer will be entitled to deduct/recover the Liquidated Damages for the delay , unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed per iod as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

8.0 Agreement

- 8.1 After issue of the Letter of Intent / Award, the Purchaser shall prepare the Agreement on the stamp paper on the Form enclosed as Annexure Confor Supply & Erection contracts and the parties shall sign the said Agreement within 30 Days from the date of issue of Letter of Intent / Award. The expenses of completing and stamping the agreement shall be borne by the Contractor. The Contractor shall furnish 3 sets of such Contract Agreements to the Purchaser. After the Agreement, one original set shall be handed over to the Contractor and the remaining two sets shall be retained by the Purchaser.
- 8.2 After the bid has been accepted by the Purchaser, all orders or instruct ions to the Contractor shall, except as herein otherwise provided, be giv en by the Engineer in Charge or his authorised representative, in writing , on behalf of the Purchaser.

9.0 Integrity Pact

To improve transparency and fairness in tendering process the Purchaser/ Employer is to implement a transparency pact. The Pre-Contract integrity pact, signed by all the bidder and the Purchaser/ Employer shall commit t he persons/officials of both the parties, not to exercise any corrupt/fraudul ent/collusive/coercive practices in the tendering process and also during i mplementation of the contract.

Pre-Contract Integrity Pact is to be executed on plain paper at the time of Submission of Bid and Pre-Contract Integrity Pact on non-judicial Stamp P aper of appropriate value (Rs. 100/-) shall be executed prior to signing of

Notification of Award by the Successful bidder.

10.0 Warrantee:

The equipment/ items shall be warranted against poor quality or workm anship of material or manufacturing defects for a minimum period of 12 months commencing upon the setting to work of item/ plant or 18 mont hs from the date of despatch whichever is earlier. During the Warrantee period the Supplier shall repair/replace the defected items free of cost a nd no conveyance or any other charges shall be paid. If any defect is no t remedied within a reasonable time, the Purchaser may proceed to do t he work at the Supplier's risk and expense, but without prejudice to oth er rights, which the Purchaser may have against the Supplier in respect of such defects

11.0 Transit Insurance:

Transit Insurance shall be borne by the Supplier and shall be reimbursed as per actual against documentary evidence subject to maximum of quoted amount.

12. Earnest Money Deposit (EMD):

EMD amounting to Rs. 11,000/- shall be deposited through RTGS /NEFT or Valid MSE or Start-up or ot her Exemption certificate towards exemption of Bid Security / EMD as per GeM GTC. Bank Guarantee in any format shall not be considered. The bid of the bidder may be rejected if BG will be submitted f or EMD.
