a) If the Contractor does not submit the Performance Security within the sti pulated period due to any valid reason, Tender Inviting Authority may gr ant time extension for submission of performance security based on the request of Contractor. In case, the Contractor does not submit performance security without a valid reason, the Employer shall impose simple interest @12% per annum on the full amount of applicable performance security (along with applicable taxes, if any) for the period of delay in submissi on of performance security. The interest on delayed period shall be calculated on pro rata basis for number of delayed days.

The interest accrued shall be payable by the Contractor within 14 days fr om the date of intimation by Tender Inviting Authority in form of Bank De mand Draft/ Banker Cheque in favour of 'NHPC Ltd', otherwise the same shall be recovered from any payment due or become due against bills / any other amount lying with NHPC.

The delayed submission of Performance Security by the Contractor shall be recorded in substantial completion and final completion certificates. Further, no claim for extension of time for completion period or any other type of claim on account of delayed submission of performance security shall be entertained.

- b) If contractor fails to submit the Performance Security within 45 days (for the contracts having time for completion - up to 12 months) or 60 days (f or the contracts having time for completion-more than 12 months) from t he date of issue of Letter of Award (LOA)/ GeM Contract, then following a ctions shall be taken against such Contractor
 - (i) Award shall summarily be terminated.
 - (ii) EMD/ Bid security shall be forfeited.
 - (iii) The bidder shall be debarred/ banned to participate in the busines s dealings with NHPC for a period of one year.

The performance security will be forfeited and credited to the procuring entity's account in the event of a breach of contract by the contractor. It should be refunded to the contractor without interest, after he duly performs and completes the contract in all respects but not later than 90 (nin ety) days of completion of all such obligations including the warranty un der the contract. Return of Bid/ Performance Securities should be monito red and delays should be avoided. If feasible, the details of these securities may be listed in the e-Procurement Portal, so make the process trans parent and visible.

6.0 Completion Period:

Total completion period for complete items engineering, design, manufactur ing, quality assurance, shop assembly & testing, delivery at the site is 04 m onths from date of award. The site storage and preservation, installation, testing, commissioning, handing over to NHPC after completion for one unit is 15 days per unit. The written intimation regarding site availability shall be done by NHPC to start the work.

7.0 Liquidated Damages:

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the B uyer will be entitled to deduct/recover the Liquidated Damages for the delay , unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed per iod as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

8.0 Agreement

8.1 After issue of the Letter of Intent / Award, the Purchaser shall prepare the Agreement on the stamp paper on the Form enclosed as Annexure Confor Supply & Erection contracts and the parties shall sign the said Agreement within 30 Days from the date of issue of Letter of Intent / Award. The expenses of completing and stamping the agreement shall be borne

by the Contractor. The Contractor shall furnish 3 sets of such Contract A greements to the Purchaser. After the Agreement, one original set shall be handed over to the Contractor and the remaining two sets shall be re tained by the Purchaser.

8.2 After the bid has been accepted by the Purchaser, all orders or instruct ions to the Contractor shall, except as herein otherwise provided, be giv en by the Engineer-in-Charge or his authorised representative, in writing , on behalf of the Purchaser.

9.0 Integrity Pact

To improve transparency and fairness in tendering process the Purchas er/ Employer is to implement a transparency pact. The Pre-Contract integrity pact, signed by all the bidder and the Purchaser/ Employer shall commit the persons/officials of both the parties, not to exercise any corrupt/fraudulent/collusive/coercive practices in the tendering process and also during implementation of the contract.

10.0 Warrantee:

The equipment/ items shall be warranted against poor quality or workm anship of material or manufacturing defects for a minimum period of 12 months commencing upon the setting to work of item/ plant or 18 mont hs from the date of despatch whichever is earlier. During the Warrantee period the Supplier shall repair/replace the defected items free of cost a nd no conveyance or any other charges shall be paid. If any defect is no t remedied within a reasonable time, the Purchaser may proceed to do t he work at the Supplier's risk and expense, but without prejudice to oth er rights, which the Purchaser may have against the Supplier in respect of such defects.

11.0 Transit and Erection Insurance:

All the supplies should be insured from the manufacturer/ supplier unit up to p ower house, Uri Power Station during transit, handling, storage, and erection of the equipment by the contractor himself. The claim for any damage/ shortage etc. shall be lodged by the contractor. The contractor shall liable to replace the lost/damaged materials at earliest so that the erection schedule should not be affected.

- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
