Amendment & Time extension

The following is amended in respect of NIT published vide: No. NH/CPS-1/P&C/W-1557/2025-26/297 Dated: 25/10/2025 for "Dhai Nala (right bank) Approach Road R-Wall on TPH Road":

1. ITB Clause No. 22.2 is amended as below:-

22.2 In case bids are invited on Item Rate Method and if the bid of the successful bidder is front loaded (i.e. the items which are to be executed in earlier part of construction period, are quoted high or bid with low rated items to be executed in the later part of contract period) in relation to the Engineer's estimate of the cost of work to be performed under the contract, the Employer may require that the amount of the performance security set forth in Clause 27 of ITB be increased to a level sufficient to protect the Employer against financial loss in the event of default of the successful Bidder under the Contract.
